- Failure to follow all of the requirements may result in property damage, bodily injury, or even death.

**Young children should be carefully supervised when they are in the same room as the appliance. Toddlers, young children, and others may be susceptible to accidental contact burns. A physical barrier is recommended if there are at-risk individuals in the house. To restrict access to a fireplace or stove, install an adjustable safety gate to keep toddlers, young children, and other at-risk individuals out of the room and away from hot surfaces.**

**Children and adults should be alerted to the hazards of high surface temperature and should stay away to avoid burns or clothing ignition. Do not touch the hot surfaces of the heater. Educate all children about the danger of a high-temperature heater.**

**Due to the high temperature, the heater should be located out of traffic and away from furniture and draperies.**

- This unit must be installed by a qualified installer to prevent the possibility of an explosion.
- This appliance must be installed in accordance with all local codes if any; if not, in U.S.A. follow ANSI Z223.1 and NFPA 54(88), in Canada follow CSA B149.1.
- A manufactured home (USA only) or mobile home OEM installation must conform with the Manufactured Home Construction and Safety Standard, Title 24 CFR, Part 3280, or, when such a standard is not applicable, the Standard for Manufactured Home Installations, ANSI/NCSBCS A225.1, or Standard for Gas Equipped Recreational Vehicles and Mobile Housing, CSA Z240.4. This appliance may be installed in Manufactured Housing only after the home is site located.
- All exhaust gases must be vented outside the structure of the living area. Combustion air is drawn from outside the living-area structure. The venting must not be connected to a chimney flue serving a separate solid-fuel burning appliance.
- Notify your insurance company before hooking up this fireplace.
- The instructions in this manual must be strictly adhered to. Do not use makeshift methods or compromise in the installation. Improper installation will void the warranty and safety listing.
- This heater is approved for use with natural gas (NG) or propane (LP). Burning the incorrect fuel will void the warranty and safety listing and may cause an extreme safety hazard. Direct questions about the type of fuel used to your dealer.
- Contact your local building officials to obtain a permit and information on any installation restrictions or inspection requirements in your area.
- If the flame becomes sooty, dark orange in color, or extremely tall, do not operate the heater. Call your dealer and arrange for proper servicing.
- It is imperative that control compartments, screens, or circulating air passageways of the heater be kept clean and free of obstructions. These areas provide the air necessary for safe operation.
- Do not operate the heater if it is not operating properly in any fashion or if you are uncertain. Call your dealer for a full explanation of your heater and what to expect.
- Do not store or use gasoline or other flammable liquids in the vicinity of this heater.
- Do not operate if any portion of the heater was submerged in water or if any corrosion occurs. Immediately call a qualified service technician to inspect the appliance and to replace any part of the control system and any gas control which has been underwater.



## Safety Warnings (continued)

- Because this heater can be controlled by a thermostat there is a possibility of the heater turning on and igniting any items placed on or near the appliance.
- Light the heater using the built-in igniter. Do not use matches or any other external device to light your heater.
- Never remove, replace, modify, or substitute any part of the heater unless instructions are given in this manual. All other work must be done by a trained technician. Don't modify or replace orifices.
- The viewing glass should be opened only for conducting service.
- Allow the heater to cool before carrying out any maintenance or cleaning.
- Operate the heater according to the instructions included in this manual.
- If the main burners do not start correctly turn the gas off and call your dealer for service.
- This unit is not for use with solid fuel.
- Do not place anything inside the firebox (except the optional artwork).
- **Warning:** Do not operate appliance with the glass front removed, cracked, or broken. Replacement of the glass should be done by a licensed or qualified service person.
- If the glass is broken, it must be fully cleaned up in a safe manner and the appliance must be inspected by a licensed or qualified service person.
- Do not throw this manual away. This manual has important operating and maintenance instructions that you will need at a later time. Always follow the instructions in this manual.
- Instruct everyone in the house how to shut the gas off to the appliance and at the gas main shutoff valve. The gas main shutoff valve is usually next to the gas meter or propane tank and requires a wrench to shut off.
- A barrier designed to reduce the risk of burns from the hot viewing glass is provided with this appliance and shall be installed for the protection of children and other at-risk individuals.
- If the barrier becomes damaged, the barrier shall be replaced with the manufacturer's barrier for this appliance.
- Clothing or other flammable material should not be placed on or near the appliance.
- Any safety screen, guard, or barrier removed for servicing an appliance must be replaced prior to operating the appliance.
- Installation and repair should be done by a qualified service person. The appliance should be inspected before use and at least annually by a professional service person. More frequent cleaning might be required due to excessive lint from carpeting, bedding material, et cetera. It is imperative that control compartments, burners, and circulating air passageways of the appliance be kept clean.

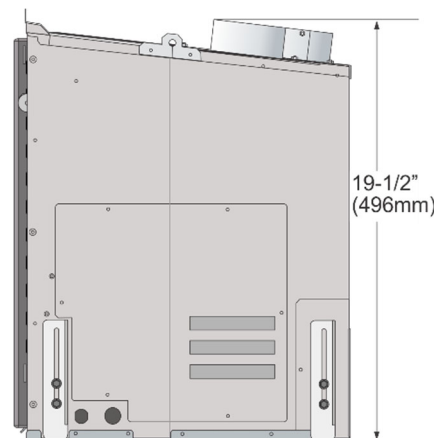
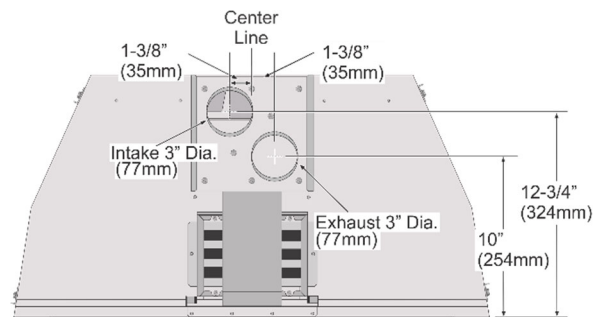
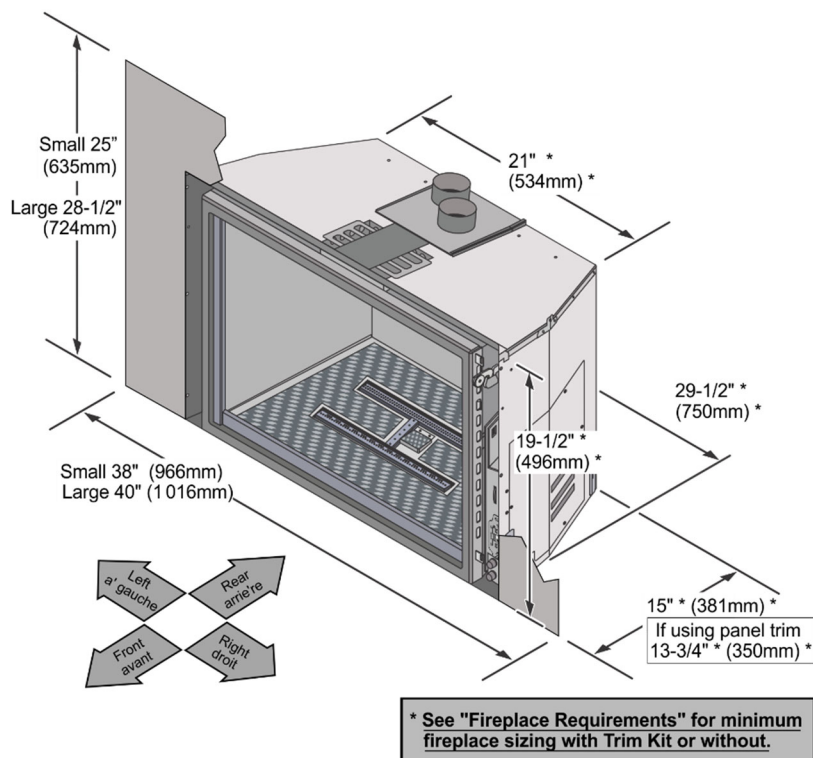

## Fuel

This heater is shipped in natural gas (NG) configuration but may be converted to propane (LP) using the LP Conversion Kit (included) and the LP stepper motor (SKU 250-01463 or 4 pk SKU 94400999, sold separately). The sticker on top of the gas control valve will verify the correct fuel.

## Installation Warnings

---

- Failure to follow all of the requirements may result in property damage, bodily injury, or even death.
- This heater must be installed by a qualified installer who has gone through a training program for the installation of direct vent gas appliances.
- The installation must conform with local codes or, in the absence of local codes, the National Fuel Gas Code, ANSI Z223.1/NFPA 54, or the National Gas and Propane Installation Code, CSA B149.1.
- In Manufactured or Mobile Homes must conform with Manufactured Home Construction and Safety Standard, Title 24 CFR, Part 3280, or, when such a standard is not applicable, the Standard for Manufactured Home Installations, ANSI/NCSCBS A225.1. This appliance may be installed in Manufactured Housing only after the home is site located.
- The heater is designed to operate on natural gas, or propane (LP).
- All exhaust gases must be vented outside the structure of the living area. Combustion air is drawn from outside the living-area structure.
- Notify your insurance company before hooking up this heater.
- The requirements listed below are divided into sections. All requirements must be met simultaneously. The order of installation is not rigid – the qualified installer should follow the procedure best suited for the installation.

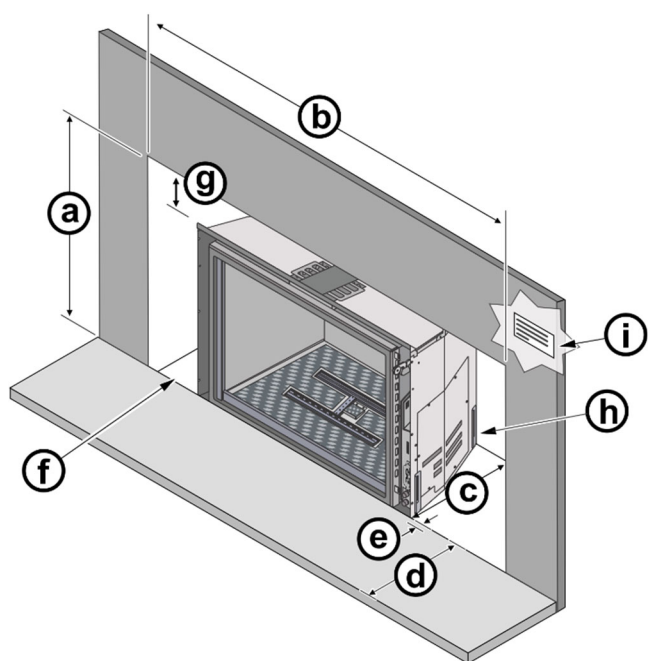
## Order of Installation

---

1. Run gas line to the fireplace.
2. Remove the glass frame.
3. Run vent through fireplace chimney. On larger fireplaces, the vent connector may be left in place. For smaller fireplaces, remove the vent connector. See "Vent Connector Removal and Installation" for details.
4. Place insert into position and attach the gas line and vent.
5. Remove the Media Tray.  
**NOTE:** If using propane (LP), remove the burners and convert the appliance at this time.
6. Install the firebacks.
7. Replace the burners if removed earlier for LP conversion.
8. Reinstall the media tray (removed in step 5).
9. Install the media (Crushed Glass, Tumbled Stones, Rock Embers, Logs - see instructions included with the media).
10. Install the surround panel (see instructions included with surround panel).
11. Replace the glass
12. Install the face (see instructions included with the face).
13. Follow the instructions under "Finalizing the Installation".

## Fireplace Requirements

- Insert must be placed within a code-conforming masonry fireplace or tested and listed factory-built (metal) wood-burning fireplace. Repair any fireplace damage prior to installation.
- Because the insert uses a circulation blower, clean the fireplace, smoke shelf, and chimney prior to installation.
- This heater may be placed in a bedroom. Please be aware of the large amount of heat this appliance produces when determining a location.
- Do not place insulation or any other material on top of the insert. This may block the upper accent light ventilation, leading to premature bulb failure.
- The fireplace and fireplace chimney must be clean and in good working order and constructed of non-combustible materials.
- The chimney cleanouts must fit properly
- Trim panels or surrounds shall not seal ventilation openings in the fireplace

- (f) The gas and electrical line should be installed prior to installing the heater.
- (g) For tight fits (under 24") see the section "Removing the Vent Connector".
- (h) See "Leveling Legs" for details on leveling the heater.

- (i) Attach the "This fireplace has been altered..." plate to the fireplace (use two screws or other suitable method). You may wish to place it in a location where it will be covered by the surround panels.

- Back of Insert to Inside of Fireplace 1/2" (13mm)
- Top of Insert to Inside of Fireplace 3/4" (20mm)

### Masonry Fireplace Hearth Requirements

A panel trim kit is available for this appliance. When using the kit, the appliance will sit forward of the fireplace opening 1-1/4" (32mm).

**WARNING:** A non-combustible hearth is not required in front of the appliance. However, if the heater is installed next to the floor, we recommend a hearth to protect the flooring surface from discoloration or other negative impacts from the heater.



## Factory-Built (Metal) Wood-Burning Fireplace Requirements

The damper ("A") and grate (with log set) ("B") must be removed (see the illustration below)

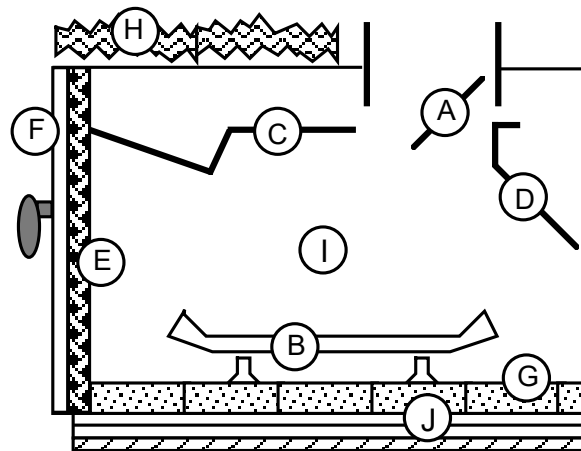
The smoke shelf ("C"), internal baffles ("D"), screen ("E"), masonry lining or refractory ("G" & "I"), and metal or glass doors ("F") may be removed (if applicable)

The fireplace must be permanently marked to indicate that it has been altered and is no longer suitable for burning solid fuel (wood) unless the removed parts are re-installed. Cutting of any sheet metal parts is prohibited.

WARNING: This fireplace has been converted for use with a fireplace insert and cannot be used for burning wood or solid fuels unless all original parts have been replaced and the fireplace re-approved by the authority having jurisdiction. 0530

The metal floor ("J") of the firebox may be removed in certain cases\*.

The insulation ("H"), and any structured rigid frame members must not be removed or altered (side and top of door frame, side, and top of the face of the fireplace, metal sides, etc.).



**\*CAUTION** – Removal of the firebox floor of a factory-built solid fuel fireplace in order to accommodate the installation of a gas-fired fireplace insert is not covered under (ANSI Z21.88 – CSA 2.22 or ANSI Z21.50 – CSA 2.33) standard(s) used to certify the gas-fired fireplace insert or UL 127 and ULC S627 standards used to certify solid fuel factory-built fireplaces. The Intertek safety certification will not apply to this installation method. This installation method must be deemed acceptable by the Authority Having Jurisdiction (AHJ) prior to the gas-fired fireplace insert being installed. The sheet metal base (or metal wrap) of the fireplace must be left in place and a minimum 1/2" cement board sheet placed under the entire length and width of the appliance.

If the factory-built fireplace has no gas access hole(s) provided, an access hole of 1-1/2 inch (37.5 mm) or less may be drilled through the lower sides or bottom of the firebox in proper workmanship like manner. This access hole must be plugged with non-combustible insulation after the gas supply line has been installed.

## Factory Built Fireplace Hearth Requirements

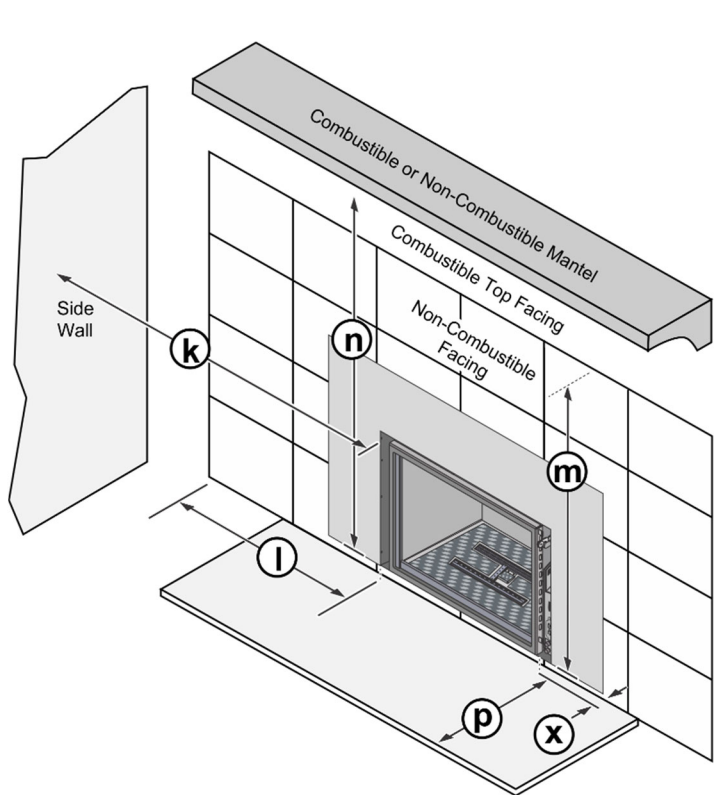
- 1/2" of non-combustible material is required underneath the entire footprint of the insert.

**WARNING:** A non-combustible hearth is not required in front of the appliance. However, if the heater is installed next to the floor, we recommend a hearth to protect the flooring surface from discoloration or other negative impacts from the heater.



## Clearances

Due to the high temperature of the heater, it should be located out of traffic and away from furniture and draperies.

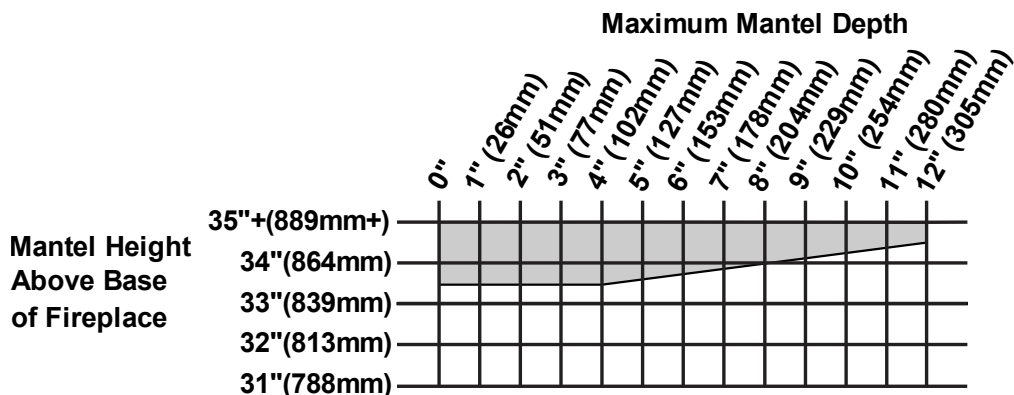

**NOTE:** the non-combustible top facing must extend 32-3/8" (823mm) above the base of the insert or to the bottom of the mantel (whichever is less).

## Mantel Clearances

The maximum mantel depth is 12" (305mm).

**NOTE:** The combustible area above the non-combustible facing must not protrude more than 3/4" (20mm) from the facing. If it does, it is considered a mantel and must meet the mantel requirements listed in this manual.

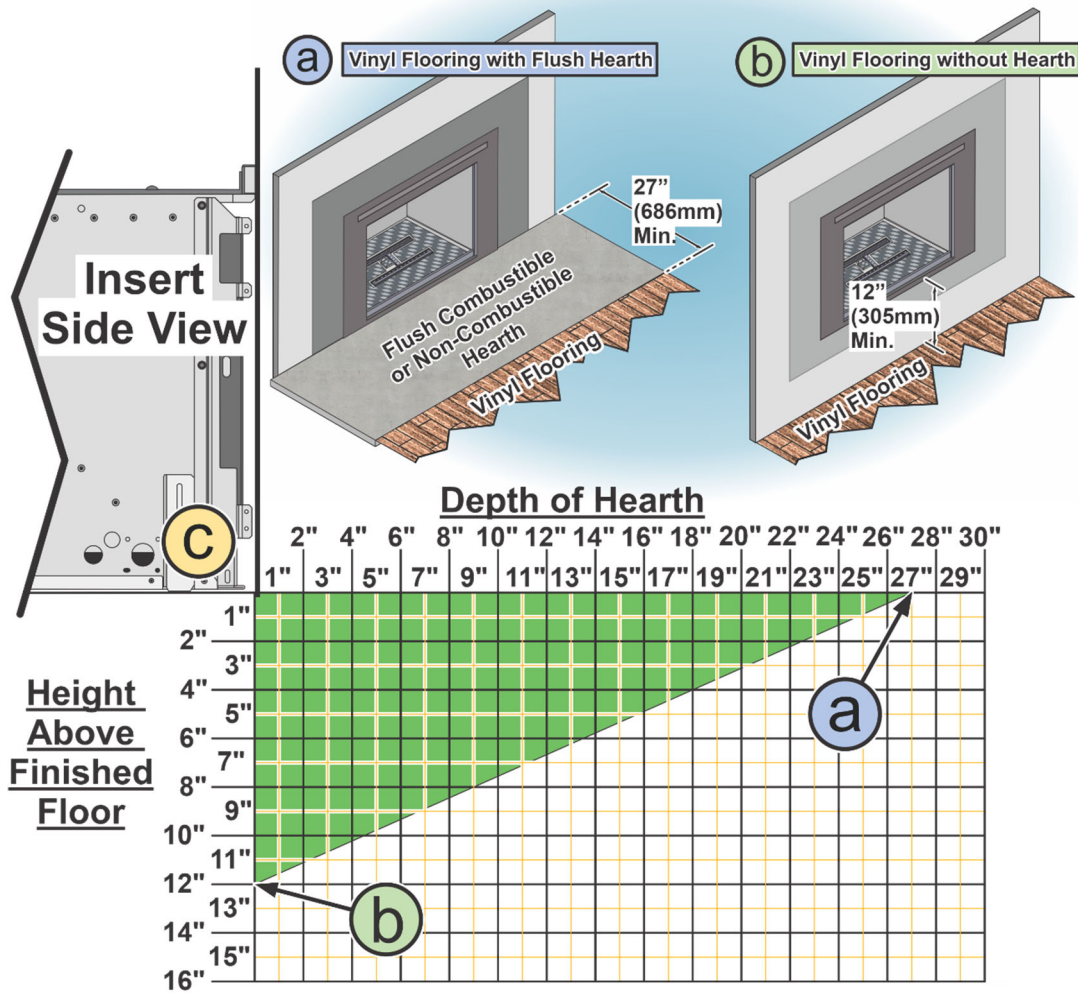


## Vinyl Flooring Hearth Recommendations

Vinyl flooring such as Luxury Vinyl Plank (LVP), Luxury Vinyl Tile (LVT), and other vinyl flooring can be sensitive to radiant heat and changes in temperature. If using vinyl flooring, we recommend installing the insert following the guidelines below. If these recommendations are not followed, the heat from the fireplace may cause discoloration, warping or other negative impacts.

**NOTE:** If using one of the hearth options, make sure to maintain the gap recommended by the manufacturer between the flooring and the hearth. Seal the gap with a flexible caulk to allow for expansion and contraction of the flooring.

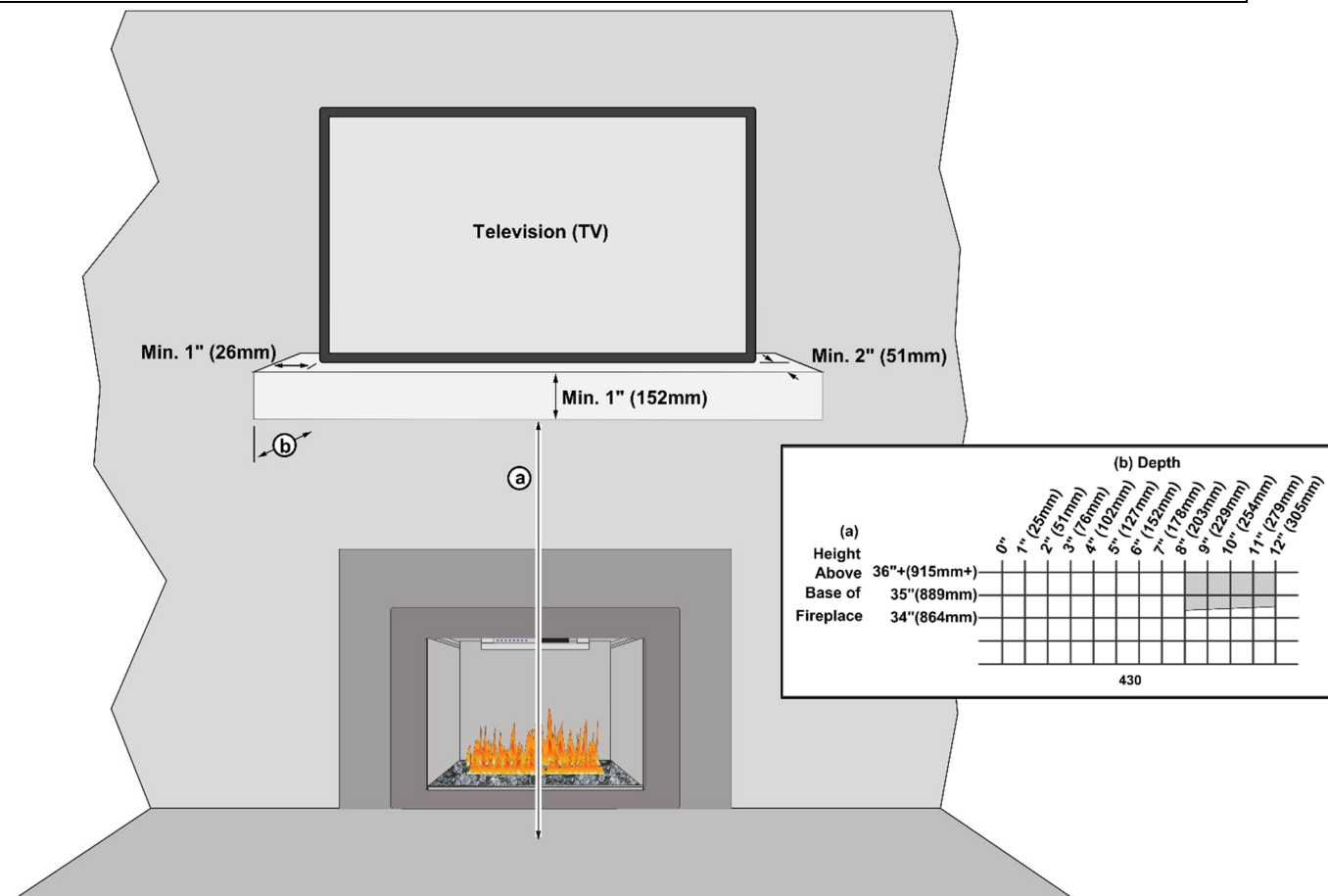


## Televisions Placed Above the Insert

The following section gives guidelines to place a television above the insert.

### IMPORTANT NOTE REGARDING TELEVISIONS AND THIS INSERT

Most television manufacturers instruct the homeowner not to place the television above a heat source like this insert. Doing so may decrease the longevity of the television and negate the warranty. If you do place a television above the insert, you should place a mantel between the insert and television. Follow the guidelines below to reduce the amount of heat reaching the television. Travis Industries does not take responsibility for any negative impact on televisions placed near this insert.



### Minimum Dimensions:

**\* Minimum mantel depth must be 8" (204mm) to allow heat to dissipate. If using a mantel larger than 8" (204mm), make sure to adjust the mantel height (a) to meet the mantel clearance (see mantel requirements on page 10 for details).**

- The mantel must extend 2" in front of the television and 1" to both sides.
- If you have a television that is greater than 6" deep (including the 1" gap behind), you will need to alter the mantel depth and height (see the example below).
- The television must have a 1" gap to the wall to allow for proper cooling.

**WIRING NOTE:** If running wiring into the enclosure, use thermal insulating wrap around the wiring. Secure the wiring to protect from contact with hot surfaces.



### ***Leveling Legs***

This heater includes front and rear leveling legs to accommodate fireplaces with a step-down firebox. Loosen the (4) bolts and adjust the legs down until the insert is properly supported and level.



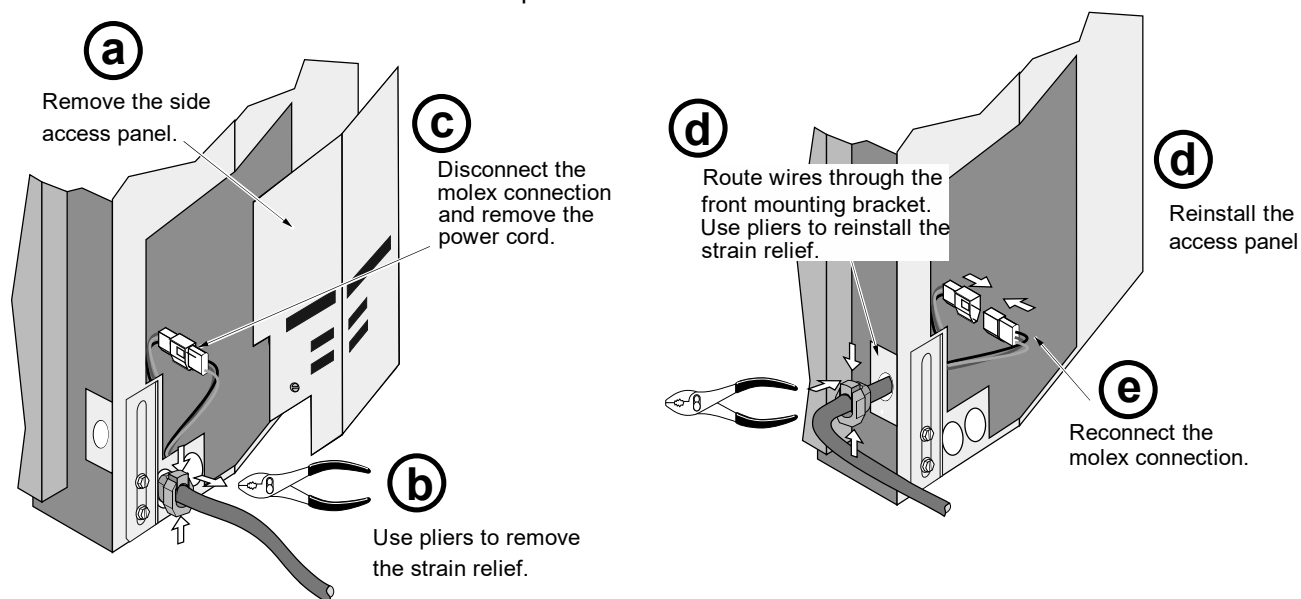
## Electrical Requirements

Travis Industries manufactures an "Insert Wiring Kit" for this insert (sku 97200315). This kit allows installers to wire 120 volt AC power into a fireplace directly to the insert, eliminating the need for an external power cord.

- Plug the power cord into a grounded 120 Volt outlet (do not remove the grounding pin).
- The appliance, when installed, must be electrically grounded in accordance with local codes or, in the absence of local codes, with the *National Electrical Code*, *ANSI/NFPA 70*, or the *Canadian Electrical Code*, *CSA C22.1*.
- Do not route the power over the appliance or near any hot or moving components.

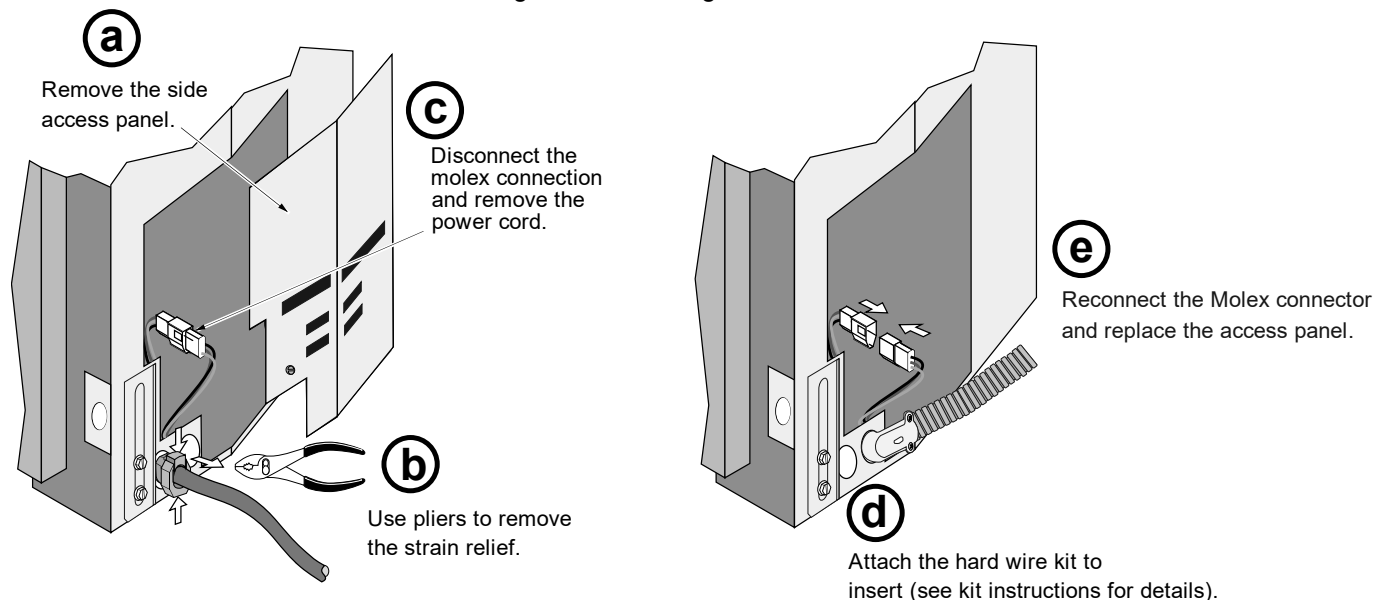
## Re-Routing the Power Cord to the Front of the Insert

The power cord is shipped attached to the side of the insert. It may be routed to the front where it exits behind the face but in front of the surround panel. See the directions below for details.



## Using the Insert Wiring Kit

See the instructions included with the wiring kit for attaching the kit to the side of the insert.



## Gas Line Requirements

### MASSACHUSETTS INSTALLATIONS - **WARNING:**

THIS PRODUCT MUST BE INSTALLED BY A LICENSED PLUMBER OR GAS FITTER WHEN INSTALLED WITHIN THE COMMONWEALTH OF MASSACHUSETTS.

#### OTHER MASSACHUSETTS CODE REQUIREMENTS:

- Flexible connector must not be longer than 36 inches.
- Shutoff valve must be a "T" handle gas cock.
- Only direct vent sealed combustion products are approved for bedrooms or bathrooms.
- Fireplace dampers must be removed or welded in the open position prior to the installation of a fireplace insert or gas log.
- A carbon monoxide (CO) detector is required in the same room as the appliance.
- The gas line must be installed in accordance with all local codes if any; if not, follow ANSI 223.1 and the requirements listed below.
- A manual shutoff valve is required within 3' of the heater. It should be placed upstream of the flex line (if used) and may be installed behind the access door inside the heater.
- The heater and gas control valve must be disconnected from the gas supply piping during any pressure testing of that system at test pressures in excess of 1/2 psig. For pressures under 1/2 psig, isolate the gas supply piping by closing the manual shutoff valve.
- Leak test all gas line joints and the gas control valve prior to and after starting the heater.
- This heater is designed either for natural gas or propane (but not for both). Check the sticker on the top of the gas control valve to make sure the correct fuel is used (see illustration on page 4).
- Installation must be performed by a qualified installer, service agency, or the gas supplier (In Massachusetts a licensed plumber/gas-fitter).

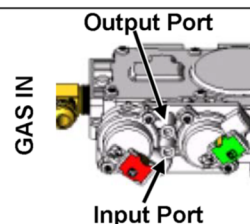

- If the pressure is not sufficient, make sure the piping used is large enough, the supply regulator is adequately adjusted, and the total gas load for the residence does not exceed the amount supplied.
- The supply regulator (the regulator that attaches directly to the residence inlet or to the propane tank) should supply gas at the suggested input pressure listed above. Contact the local gas supplier if the regulator is at an improper pressure.

### Directions for Connecting a Gas Pressure Test Gauge

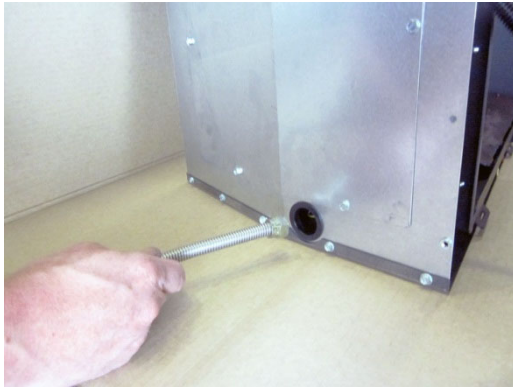
The gas control valve (shown to the right) has two test ports for testing input (line pressure) and output (manifold) pressure. Loosen the brass screw on either test port and place a 5/16" i.d. rubber or plastic tube over the tapered test port. Connect the tube to the test gauge.

**WARNING:** The brass screw must be tightened after testing to prevent gas leakage.



**Gas Line Installation**

1. Route the included flex tube through the hole in the left side of the insert and out the front as shown below.



2. Bend the flex tube up.
3. Attach the included gas shutoff valve to the end of the flex tube and gas inlet as shown below. Position so the valve handle is on the right as shown.



Leak-test all gas line connections.

## Vent Requirements

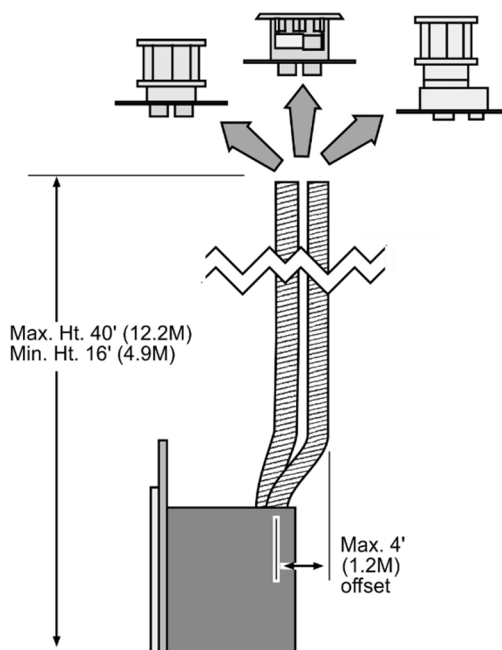
Travis Industries manufactures a vent kit specifically for this insert (sku 96200339). It includes 30' (10M) of vent, hose clamps, and a high wind cap. The flashing on the cap is 18" (458mm) by 18" (458mm).



Travis Industries manufactures a vent kit specifically for this insert (sku 96200330). It includes 30' (10M) of vent, hose clamps, and a prairie cap. The flashing on the cap is 18" (458mm) by 18" (458mm).



- The gas appliance and vent system must be vented directly to the outside of the building, and never be attached to a chimney serving a separate solid fuel or gas-burning appliance. Each direct vent gas appliance must use its own separate vent system.
- Make sure the exhaust pipe on the heater connects to the exhaust portion of the cap. The illustrations below show how the flex liners should be attached.
- The exhaust vent must reline the entire length of the chimney and terminate above the chimney top.
- Be careful not to crimp or rupture the liner when bending it into chimney offsets.
- When installed, the vent must meet all of the vent manufacturer's requirements.
- Use the following vent:  
3" UL 441 or 1777 Gas Liner for Exhaust, 3" UL 441 or 1777 Gas Liner for Air Inlet  
Duravent 6-5/8" to 3" Co-Linear Adapter and Flashing (46DVA-Gk)  
Duravent High-Wind Vertical Termination (46DVA-VCH) for high-wind applications or Prairie Cap



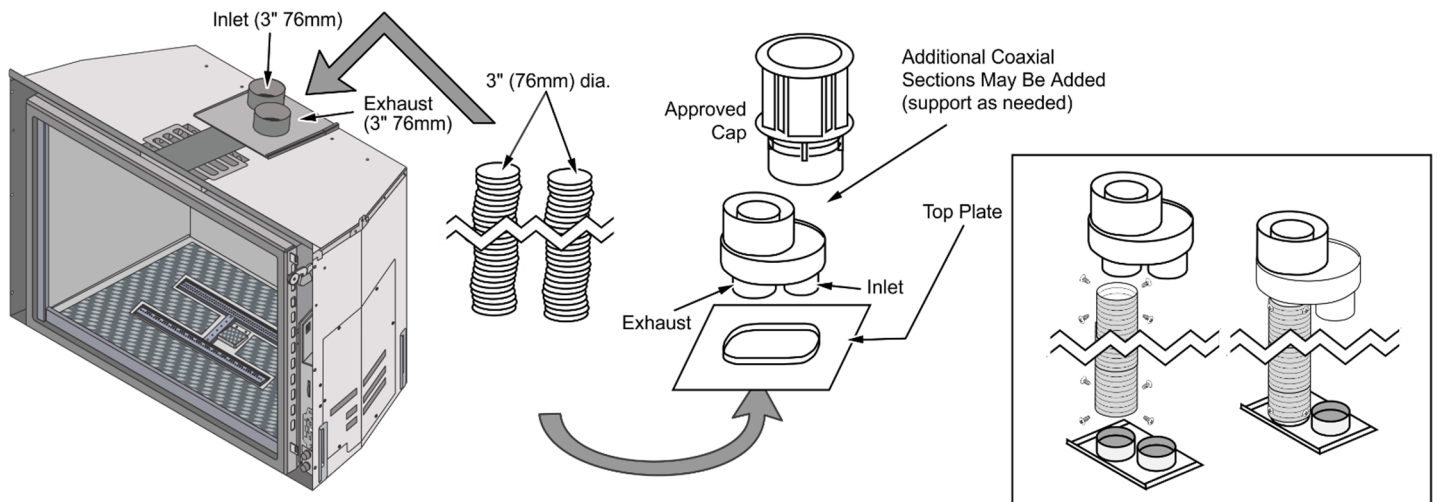
## Drafting Performance

This direct vent appliance requires natural draft to operate (similar to a wood stove or other heating appliance). Draft can be adjusted using the included restrictor. The restrictor settings detailed in the manual should be followed (variations may occur depending upon installation parameters).

Many factors may negatively influence the draft of the appliance. Travis Industries will not be responsible for improper draft due to factors such as trees, hills, buildings, obstructions, excessive wind, extreme hot or cold outdoor temperatures, restrictive vent terminations, or influence from mechanical systems.

### Vent Installation

Secure the vent to the insert and termination kit using screws.



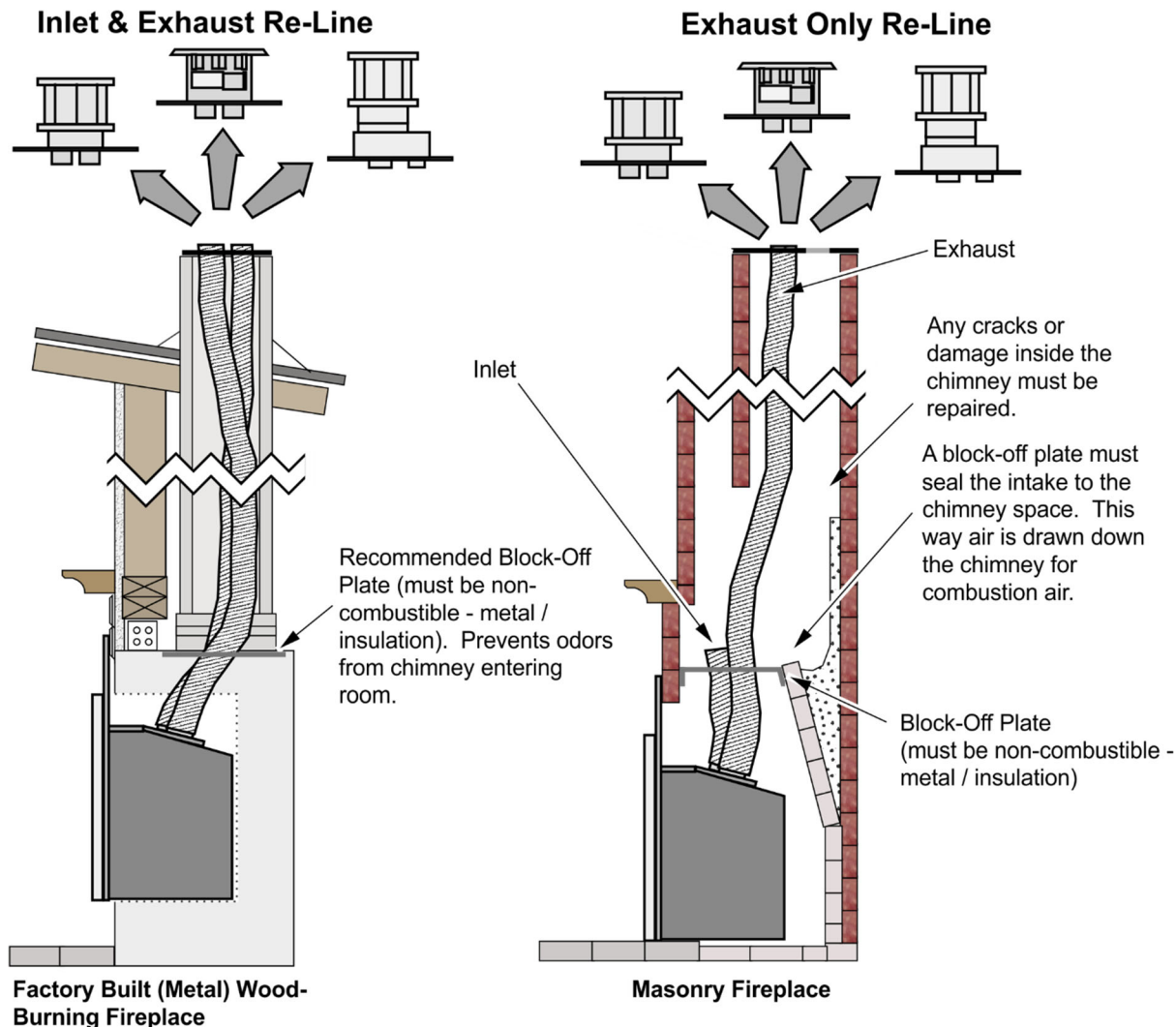
For optimum performance, keep the vent as straight as possible (no 90° bends).



## Vent Location

- An Exhaust Restrictor is built into the appliance to adjust the flow rate of exhaust gases. This ensures proper combustion for all vent configurations. Depending upon the vent configuration, you may be required to adjust the restrictor position. See “Exhaust Restrictor Settings” on page 22.

**NOTE:** You may use either re-line configuration with a masonry or zero-clearance fireplace.

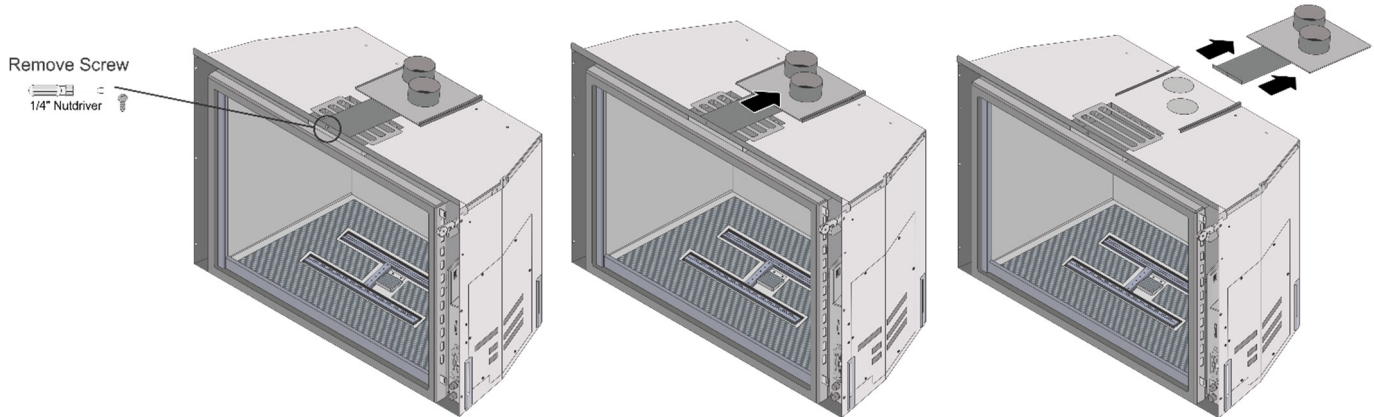
## Altitude Considerations

- This heater has been tested at altitudes ranging from sea level to 6,000 feet (1,800 M). In this testing, we have found that the heater, with its standard orifice, burns correctly with just an air shutter adjustment.
- Failure to adjust the air shutter properly may lead to improper combustion which can create a safety hazard. Consult your dealer or installer if you suspect an improperly adjusted air shutter.

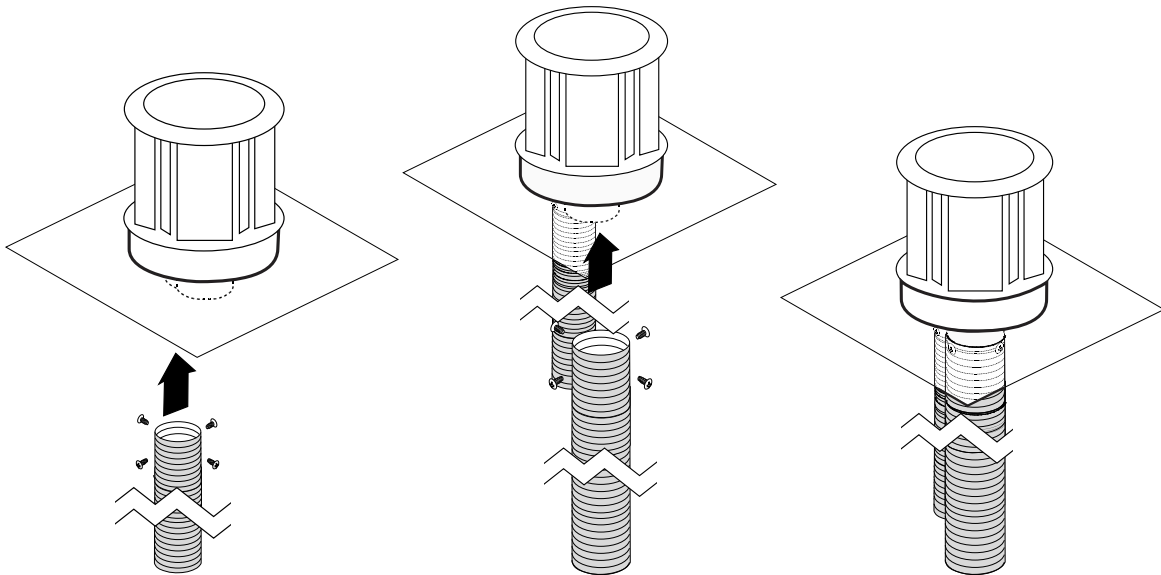
**Vent Attachment – Tight Installations**

The vent connector is shipped attached to the insert but must be removed to facilitate tight installations. See the directions below for installation.

1. Locate the screw in the top-center of the front of the insert. Use a ¼" nut driver to remove the screw and slide the connector toward the back of the insert to disengage the connector from the top of the insert.

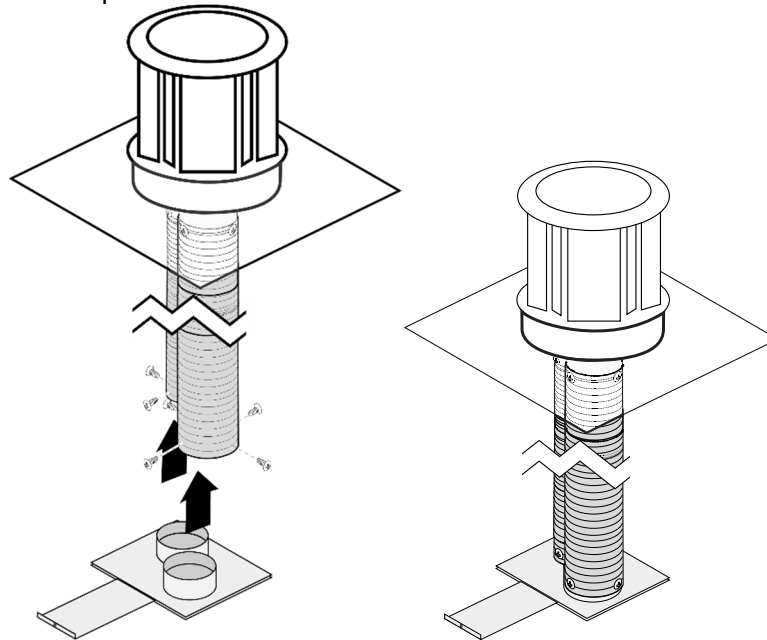


2. Stretch the liners to their full length. Attach the flex liners to the cap (secure with screws). Route the flex vent through the chimney from above.

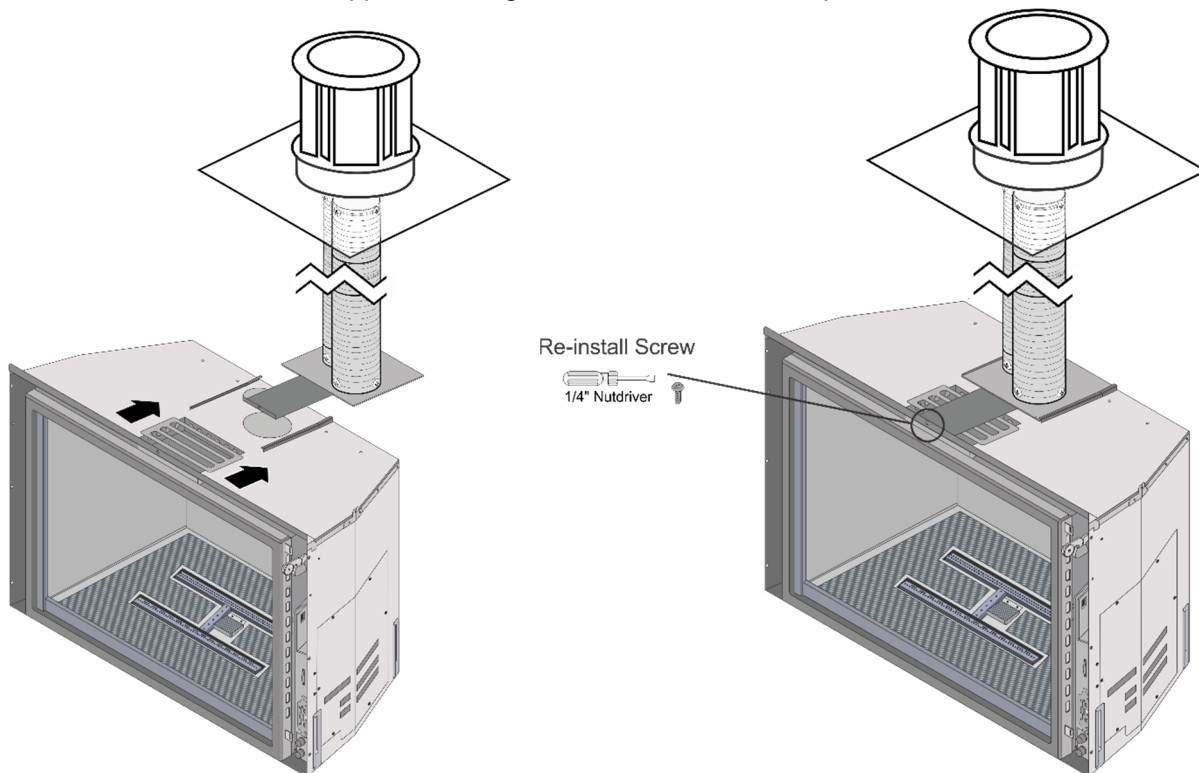




3. Pull the liners straight and cut to length (height of the insert). Attach the bottom of the flex liners to the connector, removed in step 1.

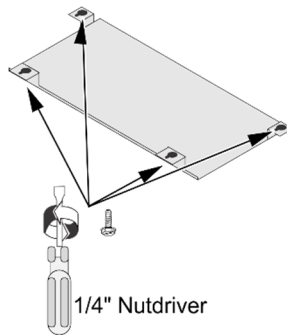


4. Slide the insert into place while guiding the vent connector into the guides on top of the insert. Secure the vent connector to the appliance using the screw removed in step 1.

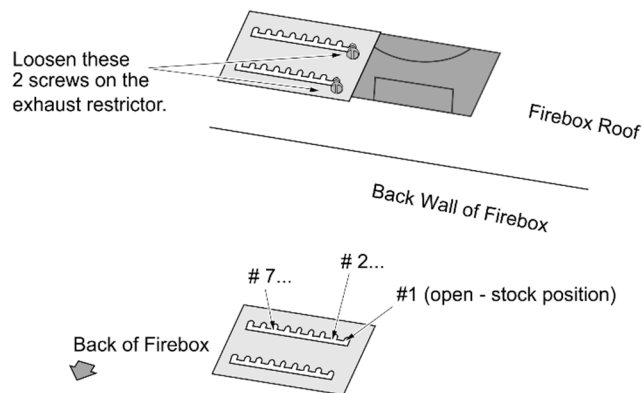


**Exhaust Restrictor Settings**

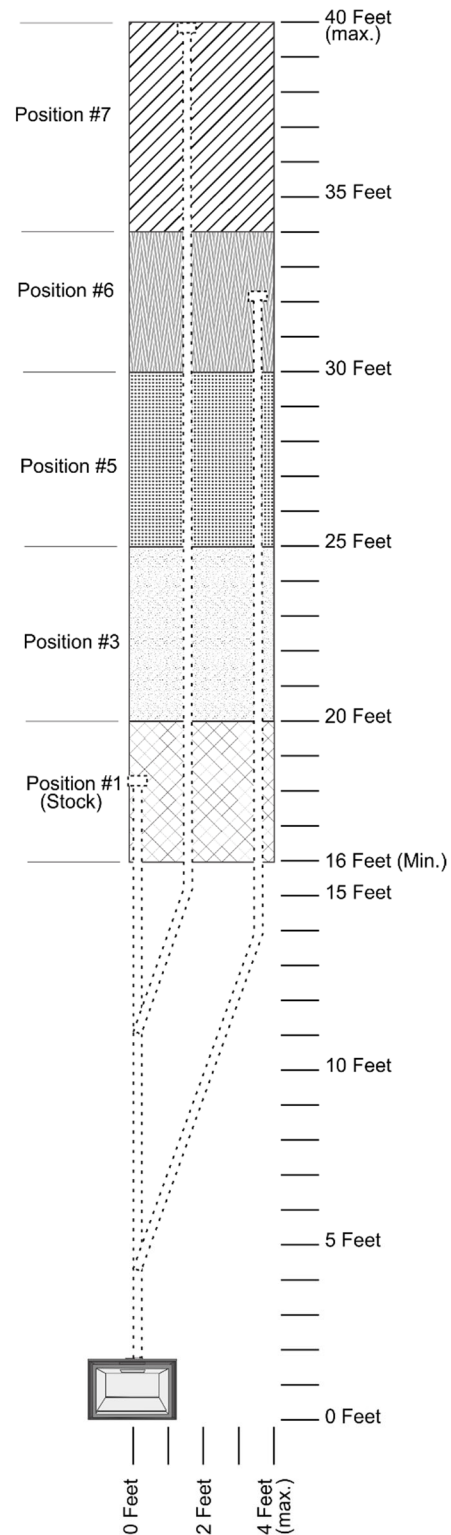
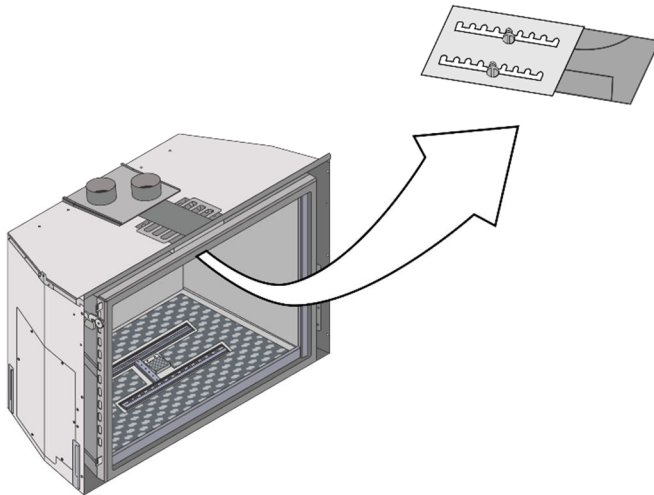
Use a 1/4" nut driver to loosen the screws that secure the baffle to the top of the firebox. Slide the baffle slightly forward until the screw heads are in line with the keyhole slots. Lower the baffle and remove from the firebox. (Re-install baffle after the restrictor has been adjusted).



Slide the restrictor to the correct position (consult the vent chart to the right to determine the proper setting for your installation). The screw location indicates the restrictor position.



In this example, the restrictor is set in the #5 position. Tighten the screws to secure the restrictor.



## Horizontal Termination

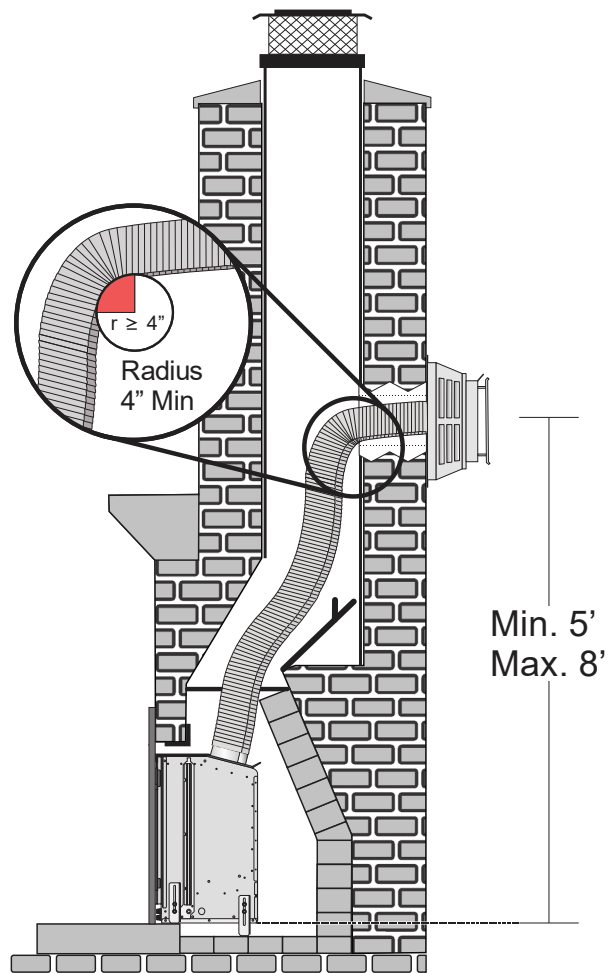
DuraVent manufactures a vent kit for horizontal that allows for terminating horizontally when installed in a masonry fireplace (not for use with ZC fireplaces). The DuraVent kit (46DVA-HCL33 and 46DVA HCL34) is approved for use with Travis Industries gas inserts.

These kits can be purchased from your Travis Industries dealer.

Refer to the kit manufacturer's instructions for details and requirements for installation. In addition to the manufacturer's requirements, the following requirements must be met:

- The termination center **MUST** be a minimum of 5' from the base of insert.
- The termination center **MUST NOT** be more than 8' from the base of the insert.
- The radius of any bends in the flexible venting **MUST NOT** be less than a 4" radius
- All portions of the venting **MUST** have at least a 1/4" rise per 12" of horizontal run



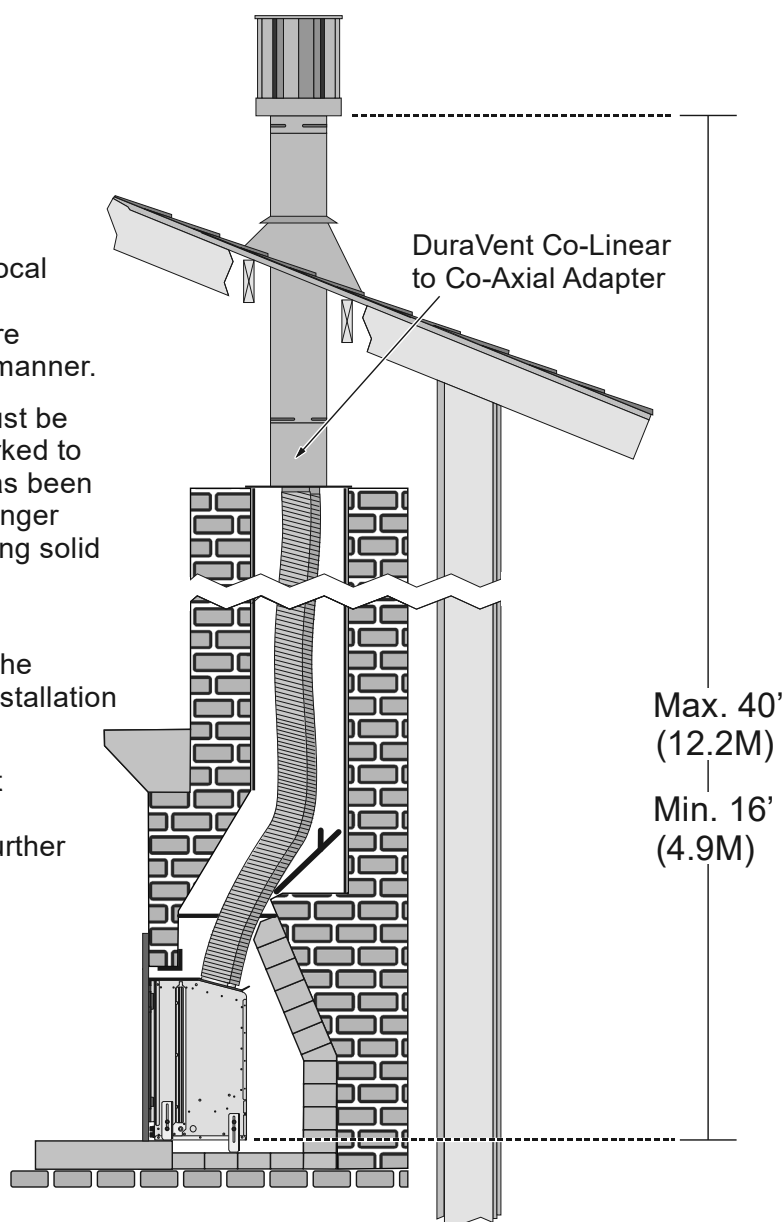
## Co-Linear to Co-Axial Pipe

DuraVent manufactures a vent kit that adapts flexible co-linear venting to co-axial pipe. This can be helpful for situations such as when a damaged masonry chimney top is removed to below the roofline or when an additional story is added to a home and the added height covers the existing masonry chimney height. The DuraVent kits (46DVA-CLTA and 46DVA-34CLTA) are approved for use with Travis Industries gas inserts.

These kits can be purchased from your DuraVent dealer.

- Check with the local Authority Having Jurisdiction before installing in this manner.
- The fireplace must be permanently marked to indicate that it has been altered and no longer suitable for burning solid fuel (wood).
- All additional requirements in the manual for the installation must be met.
- Refer to the vent manufacturer's instructions for further details.



## Glass Frame Removal and Installation



A barrier designed to reduce the risk of burns from the hot viewing glass is provided with this appliance and shall be installed for the protection of children and other at-risk individuals.



If the barrier becomes damaged, the barrier shall be replaced with the manufacturer's barrier for this appliance.



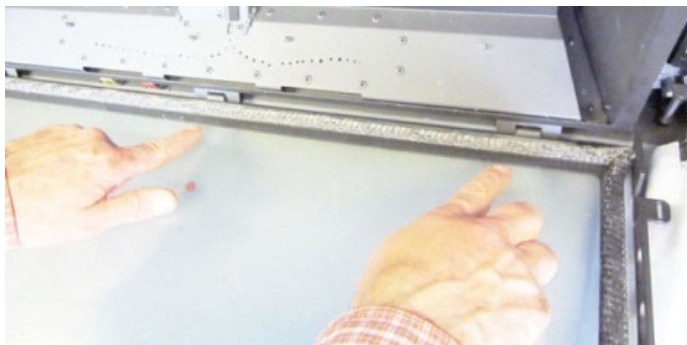
The appliance must be completely cool before removing the glass.  
Do not strike or slam the glass.

1. The glass removal tool is located at the upper right of the convection area and may be removed with a 1/4" nut driver.



**NOTE:** Replace the tool in this location after removing the glass frame.

2. Remove the glass frame as shown below. The glass frame is held in place with three tabs inserted into three slots at the bottom of the insert.



### Steps for Finalizing the Installation

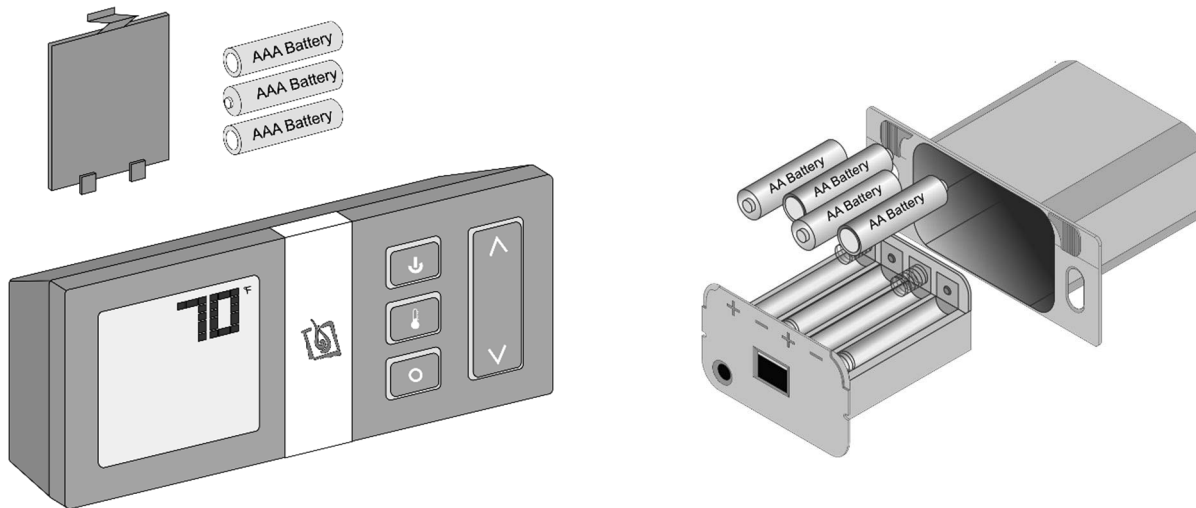

1. Remove the glass (see page 22).

**NOTE:** If using propane (LP) convert the appliance prior to installing the media.

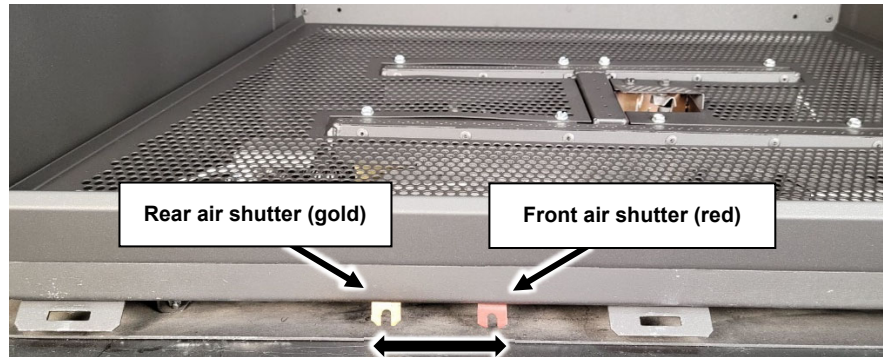
2. We recommend you purge the gas line at this time (with the glass removed). This allows gas to be detected once it enters the firebox, ensuring gas does not build up.
3. Install the four AA batteries (see illustration below). The AA batteries act as a power backup in case the household (AC) power goes out and are required for operation. Install three AAA batteries into the remote (see illustration below). Synchronize the transmitter to the IFC (see page 30).
4. Make sure the accent light bulbs are in place and work correctly.

**NOTE:** Take care to not touch the bulb with your fingers – use a cloth or paper towel).



5. Install the media (see the instructions included with the media kit).
6. Replace the glass.
7. Start the heater.
8. Leak test all gas joints.
9. Adjust the air shutter following the directions on the next page.
10. Attach the face following the directions included with the face.
11. Adjust the flame to its highest position - the flames should not contact the top of the firebox. Check the flame on low position. The flames should burn off of each burner hole. If the heater does not work correctly, contact your Travis dealer for a remedy.
12. Give this manual to the homeowner for future reference and fully explain the operation of this heater.

## Air Shutter Adjustment



Left = More Air

Let the heater burn for fifteen minutes (make sure the media and glass are in place). The flames should be yellow with no sooting. Adjust the air shutter, if necessary, to achieve the correct looking flame.





**Removing Media Tray for Fireback Installation**

1. Remove the (8) screws that secure the media tray to the burners (set the screws aside for re-installation). Lift the media tray and remove it from the firebox.

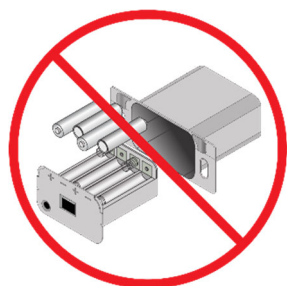


2. Install the firebacks. See the firebacks installation instructions for details.
3. Re-install the media tray assembly after the firebacks are in place.

## Before You Begin

- Read this entire manual before you use your new heater (especially the section "Safety Precautions" on pages 4 & 5). Failure to follow the instructions may result in property damage, bodily injury, or even death.

### Remote Control Warnings



#### **KEEP BATTERIES INSTALLED AT ALL TIMES**

The remote control system requires the batteries to remain in place at all times. Once the batteries are removed, the system may re-start in standing pilot mode. If this occurs when the heater is in Remote Mode, you will not be able to turn the heater off manually from the battery box.

If you need to replace dead batteries, make sure to **turn the appliance off** before removing the batteries.

**NOTE:** If the batteries go dead, the system will operate normally as long as household power (120v AC) is present.



The transmitter and IFC are radio frequency devices. Placing the transmitter in or near metal may severely reduce the signal range.



Turn off the main gas supply to the appliance during installation or maintenance. In case of remote control malfunction turn off the main gas supply to the appliance.

### **PROGRAMMING THE REMOTE**

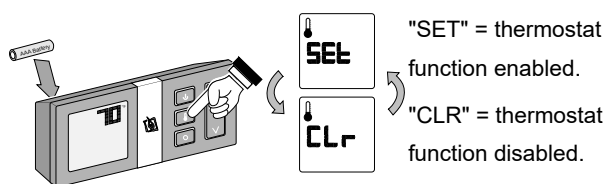
The SIT GSR2 remote may be programmed to disable the thermostat or any of the modes (flame height, blower, light, comfort control, Standing Pilot \*, or auxiliary power input). This allows you to tailor the remote to the appliance.

\* We do not recommend disabling the standing pilot option for our gas appliances. This feature may be recommended for cold regions or installations with sub-optimal venting.

#### **How to Disable/Enable the Thermostat**

The remote is shipped with the thermostat enabled.

- Remove one battery from the remote.
- Press and hold the thermostat button while replacing the battery. This will toggle the thermostat function. Repeat this process to toggle the thermostat function to the desired setting.



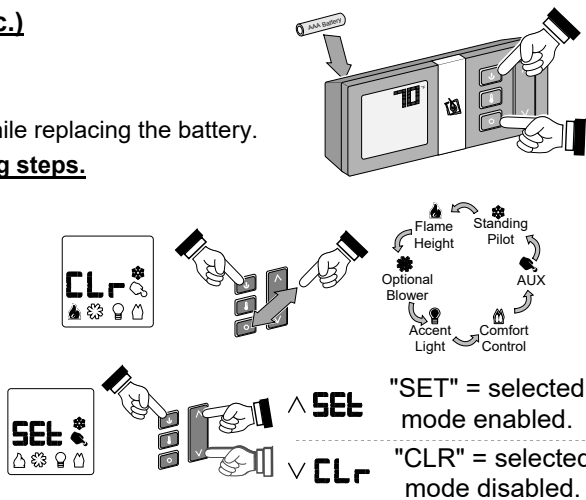
#### **How to Disable/Enable Modes (Light, Blower, etc.)**

The remote is shipped with all modes enabled.

- Remove one battery from the remote.
- Press and hold the on/off button and mode button while replacing the battery.

**Keep the on/off button depressed during the following steps.**

- While keeping the on/off button depressed, press and release the mode button until the mode that needs to be changed is illuminated.
- With the desired mode illuminated (see illustration to the right), press the "up" or "down" button to activate or clear the mode being addressed. Make sure to keep the on/off button depressed during this process.
- Release the on/off button to complete programming.



## Remote Set-Up

### Verify the Switch is on “REMOTE”

The battery holder has a switch built into it (see **Figure 1**). This switch must remain in the REMOTE position for the remote to operate.

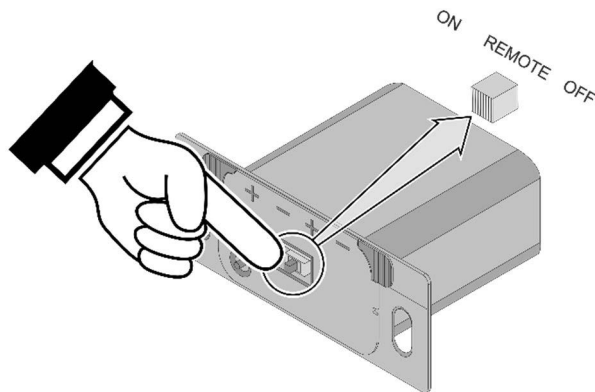

### Synchronize the Transmitter to the IFC

The transmitter will need to be synchronized to the IFC (Integrated Fireplace Control) before the remote will work correctly. Synchronizing is done in the following two steps below (see **Figure 2**):

1. Press the PRG (Program) button on the battery box (IFC will beep 3 times).
2. Press the “ON” button on the transmitter (IFC will beep 3 times).

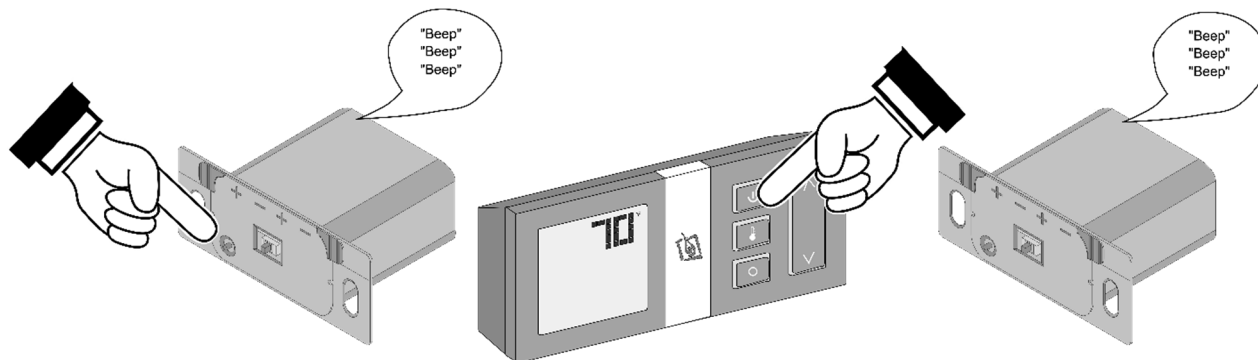

**NOTE:** If power is cut off to the IFC for an extended period of time, you may need to re-synchronize the remote.

### Clearing the System Memory

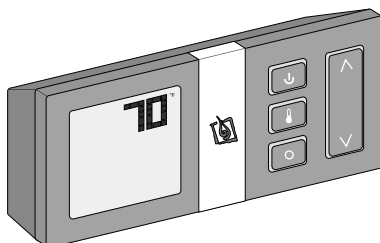
This appliance uses an Integrated Fireplace Control (IFC) to store the unique code for the remote control. If you wish to clear the system memory, **MAKE SURE GAS IS TURNED OFF TO THE APPLIANCE** then press the PRG (Program) button for 10 seconds. The pilot will start to spark repeatedly, signifying all system memory has been cleared. The system will return to its original configuration: a remote will need to be synchronized; and, the system will operate under continuous pilot mode.

## Starting the Heater for the First Time

- Burn the heater at a high setting with the blower off for an extended period (up to 48 hours). This will cure the painted surfaces. **Fumes** from the paint curing and oil burning off the steel will occur. This is normal. We recommend opening a window to vent the room.
- **Condensation** may appear on the glass each time you start the heater - this is normal.
- **Blue Flames** will occur on the heater when it first comes on. After fifteen minutes the flames will turn a more realistic yellow and orange color.
- Verify the batteries are installed.

## Location of Controls

Most features will be controlled by the included remote.



## Direct Operation

The fireplace may be directly operated from the battery holder (accessed by removing the face). The three positions are below (see Figure 3):

**ON (all the way left)** – Burner turns on (regardless of transmitter settings).

**OFF (all the way right)** – Burner turns off (regardless of transmitter settings).

**REMOTE (middle position)** – Burner is controlled by the transmitter.

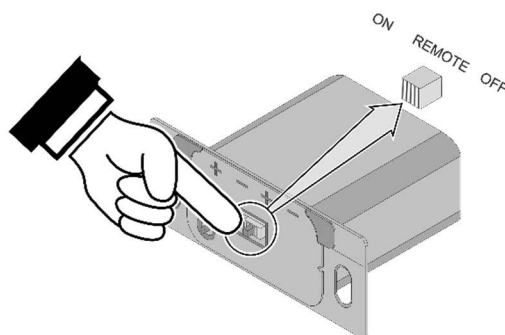

**NOTE:** When the battery holder switch is turned to ON or OFF, the mode settings (Flame Height, Comfort Control) will remain in the same state as before the switch was moved (i.e.: the IFC “remembers” the last setting). If you wish to adjust the mode settings use the transmitter mode button to adjust the settings. The thermostat and burner on/off operating functions will not work on the transmitter.

## Continuous/Intermittent Pilot Switch

This heater may run with the pilot continuously running or in intermittent mode. For most homeowners, the intermittent mode is preferred (this saves fuel, doesn't give off un-needed heat). However, in some situations, the homeowner may prefer to switch the heater to continuous pilot. The most typical reasons for switching to continuous pilot are:

- Very Cold Conditions – in very cold conditions you may notice that the burner does not light quickly, and the flames lift off the burner. If this is the situation, we recommend you switch to continuous pilot. This will create a slight draft in the vent, allowing for the burner to light quickly and draft correctly.
- Excessive Condensation on Glass After Startup – certain installations may encounter excessive fogging on the window after startup (not just the first time the heater was started). This is an aesthetic condition that may be remedied by switching the heater to continuous pilot.
- Cold Glass or Heater Front – in very cold conditions you may notice that the heater front and glass become very cold. To remedy this, switch the heater to continuous pilot.
- Frequent On / Off Operation – if you are frequently turning the heater on and off, you may wish to leave it in continuous pilot. This allows the burner to turn on more quickly, without pilot ignition delay.

### Switching from Intermittent (IPI) to Continuous Pilot (CPI)

The pilot mode on this appliance is adjusted using the remote. With the remote in the off position (thermostat off, manual off), follow the directions below to adjust the pilot mode.

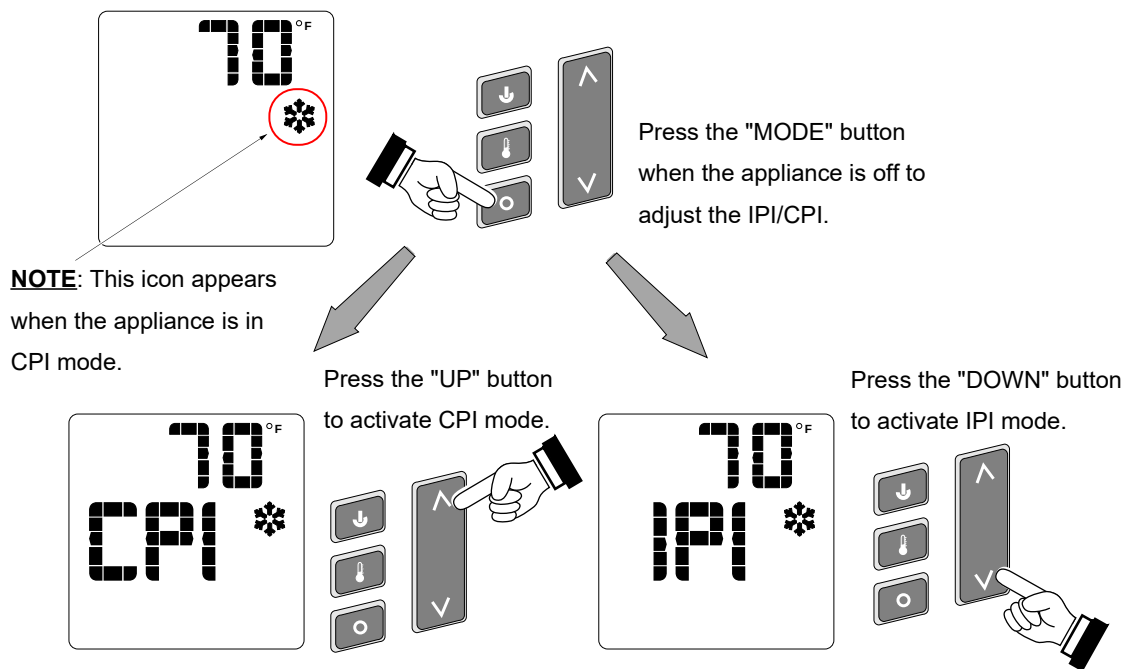
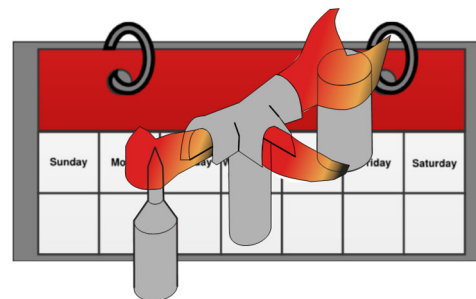

## ***Pilot Fuel Conservation Timer***

### **7 Day Pilot Shutoff Timer (applies to units in CPI mode only)**

This appliance may be equipped with a 7-day pilot shutoff timer. This timer helps conserve fuel and save money by turning the pilot off when the appliance is not used for 7 days (this timer is mandated in certain areas for conservation purposes). This applies only when the unit is in CPI (Continuous Pilot Ignition) mode. If the unit is in IPI (Intermittent Pilot Ignition) mode, the timer does not apply.



When in CPI mode the pilot will remain lit as long as the burner is engaged within a 7-day window. Each time the burner is turned on the 7-day timer resets. If the burner is not engaged within the 7-day window, the pilot will automatically revert to IPI mode and turn off to conserve fuel.

### **To switch back to CPI, simply:**

GSB2 Units: toggle the IPI/CPI switch to IPI, then back to CPI.

GSR2 Units: use the remote to toggle from IPI mode, then back to CPI mode.

To prevent the need to reset the pilot mode during the heating season, we have listed a few strategies below:

### **Option 1: Remember to periodically turn on the heater during the heating season**

If you use your heater for supplemental heat, this may be the best solution. Set a specific time, once or twice per week (e.g. 5 pm on Tuesday & Friday) to turn the heater on for a few minutes. This will reset the timer and prevent the need to restart the pilot.

### **Option 2: Use a thermostat**

GSR Units: Use the thermostat included with the appliance

GSB Units: Consult your dealer for thermostats compatible with your appliance.

The use of a thermostat will keep the room at a constant temperature and will, in most cases, keep the heater working throughout the heating season. Light the pilot at the beginning of the heating season and set the thermostat to the desired room temperature. As long as the outside temperature does not rise excessively, for seven days or more, the pilot will continue to operate.

### **Option 3: Use a programmable thermostat (GSB2 Only)**

A programmable thermostat may be set to turn on, once per week, to a high temperature for a short time. This will reset the 7-day timer and allow the heater to operate without having to restart the pilot.

## Remote Operation

When the switch on the battery holder is set to “REMOTE” the transmitter operates the fireplace. Once you understand how the transmitter works, you will be able to operate your fireplace quickly and easily.

### Display Overview

The transmitter display has four main sections (see **Figure 5**).

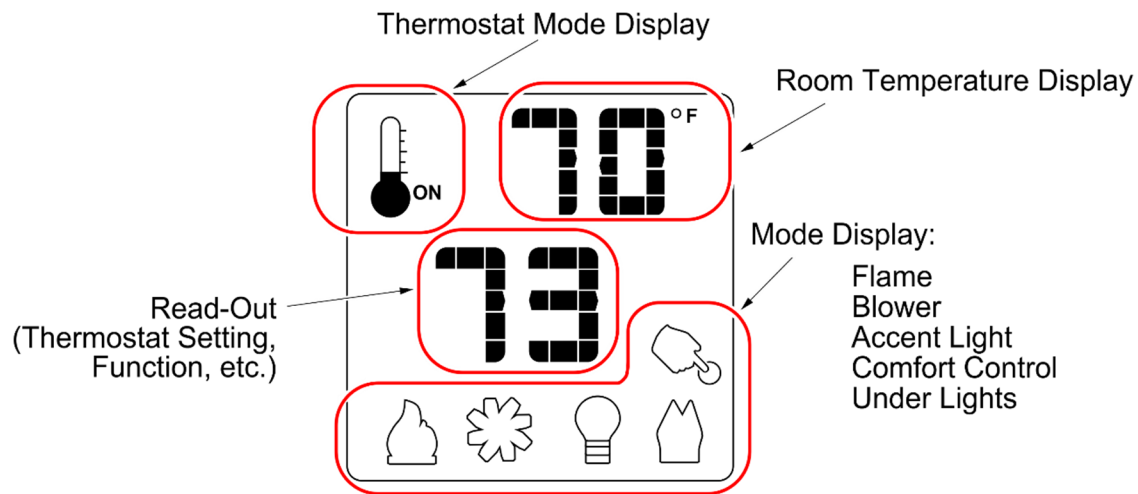

### Listen for the “Beep”

Each time you press a button on the transmitter that controls the fireplace, a “beep” will come from the IFC. When you change the thermostat target settings the IFC will not beep.

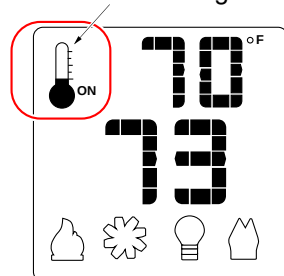
**NOTE:** When the batteries start to get low, the IFC will beep twice whenever a button is pressed. When the batteries are nearly depleted, the IFC will no longer beep. See “IFC Batteries” on page 38).



## Manual On-Off / Smart Thermostat / Standard Thermostat

Use the thermostat button to cycle through the three thermostat settings (see Figure 6).

Look here for the thermostat setting.



Press the thermostat button to cycle through the thermostat settings.

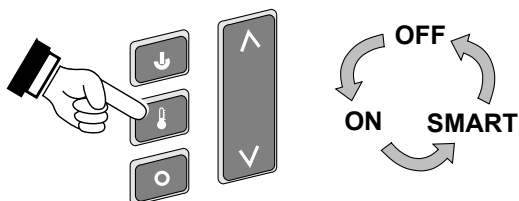

- **MANUAL ON/OFF** – The burner will turn on and off using the remote (see Figure 7). Press the On/Off button to control the burner. When off, the display will only show the current temperature.

When in manual setting, the word "OFF" will appear here.

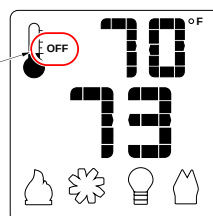
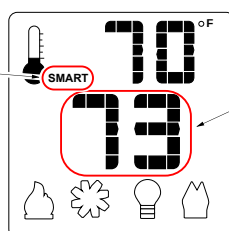

- **SMART THERMOSTAT** – While in smart thermostat, the transmitter will control the burner to achieve the target temperature (see Figure 8 below). Flame height will be adjusted up or down to allow operation without turning the burner on and off (also called "smart modulation"). To adjust the target temperature, press the UP and DOWN buttons until a suitable temperature is achieved.

When in smart thermostat setting, the word "SMART" will appear here.



This is the target temperature on the read-out. Use the up or down buttons to adjust the target temperature.

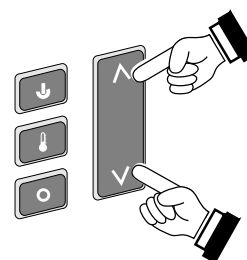
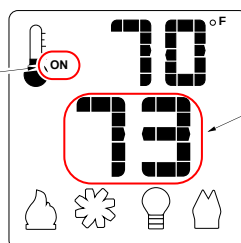

- **STANDARD THERMOSTAT** - While in standard thermostat setting, the transmitter will turn the burner on and off to achieve the target temperature (see Figure 9 below). To adjust the target temperature, press the up and down buttons until a suitable temperature is achieved.

When in standard thermostat setting, the word "ON" will appear here.



This is the target temperature on the read-out. Use the up or down buttons to adjust the target temperature.

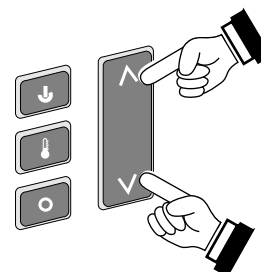


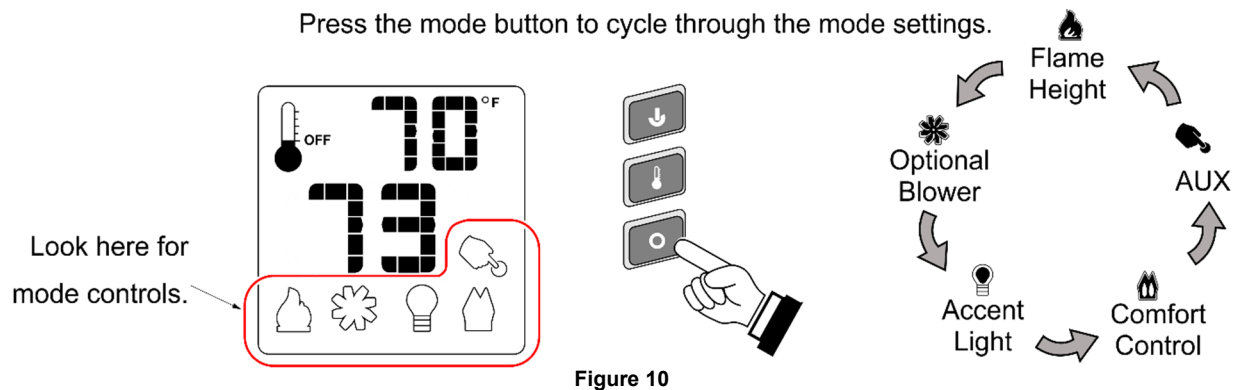

**NOTE:** If the transmitter batteries go dead while in thermostat setting (standard or smart), the appliance will shut off after approximately 24 hours.

## Mode Controls (Flame, Blower, Light, Comfort Control, Under Light)

Use the mode button to cycle through the five mode controls (see Figure 10 below).

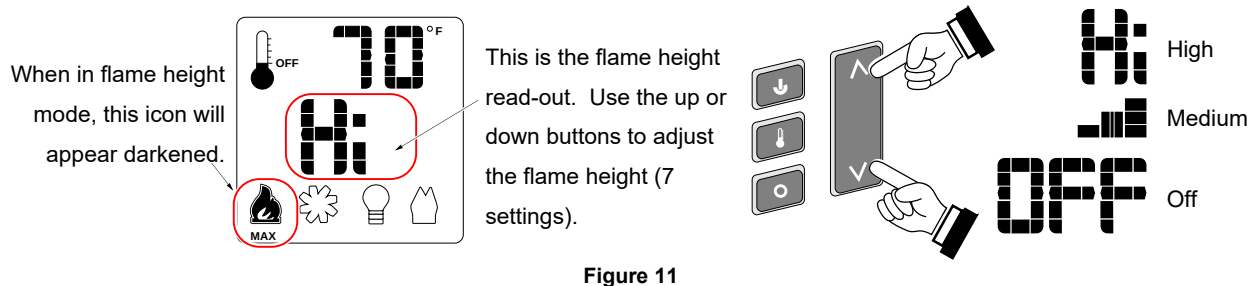
Press the mode button to cycle through the mode settings.



### Flame Height

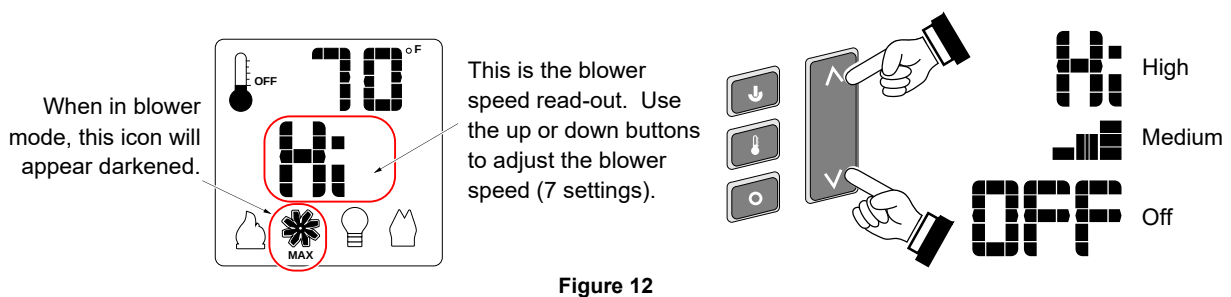
Flame height may be controlled using the UP and DOWN buttons when in Flame Height Mode (see Figure 11 below). The center display will display the 7 settings, from “OFF” to “HI” for full on.

**NOTE:** Flame height may not be adjusted if operating in Smart Thermostat setting.



### Blower Speed

The blower may be controlled using the up and down buttons when in Blower Speed Mode (see Figure 12). The center display will display the 7 settings, from “OFF” to “HI” for full on.



#### MANUAL MODE – BLOWER OPERATION

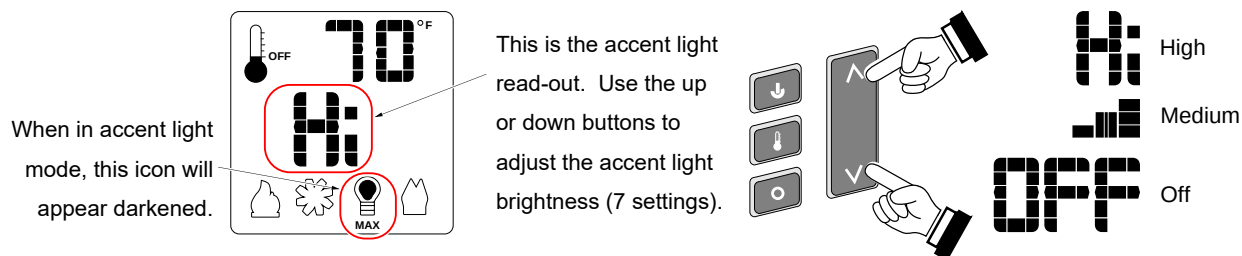
When in Manual Mode the blower will remain on, even if the burner is turned off and the heater cools.

Either manually turn the blower off, or turn off the heater by pressing the On/Off button.

## Mode Controls - continued

### Accent Light

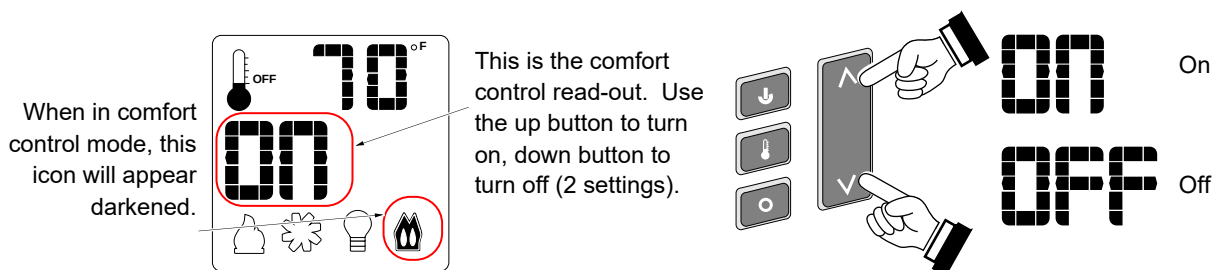
The Accent Light (night light) inside the heater may be turned on and off using the up and down buttons when in Accent Light Mode (see illustration below). The center display will display the 7 settings, from “OFF” to “HI” for full on.



**HINT:** If you wish to leave the accent light on while turning the burner off, adjust the Flame Height to “OFF” (see above).

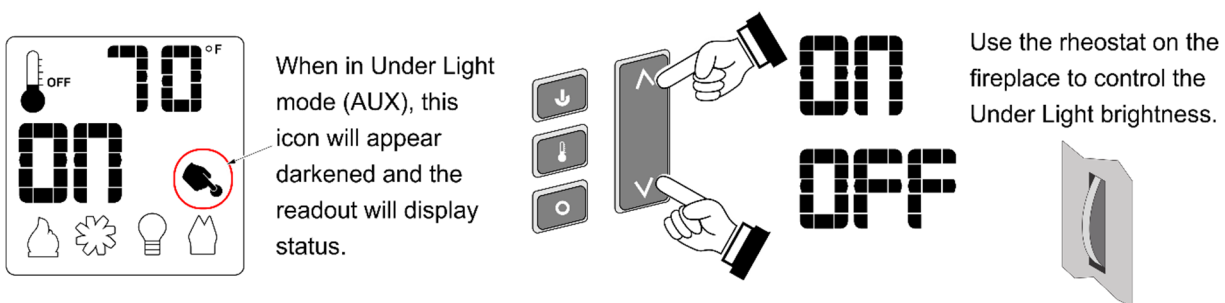
### Comfort Control (rear burner)

The comfort control (rear burner) may be turned on and off using the up and down buttons when in Comfort Control Mode (see illustration below). The center display will display either “ON” or “OFF”.



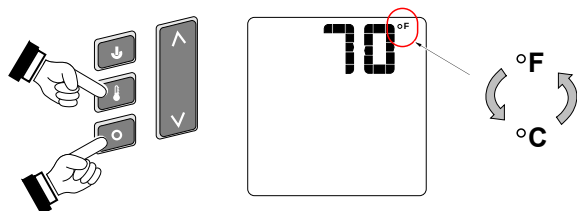
### Under Light (AUX)

The Under light may be turned on and off using the up and down buttons (see illustration below). You can adjust the brightness of the emberbed light using the built-in rheostat.



## Display Fahrenheit or Celsius

- With the system in the “OFF” position, press both the MODE and THERMOSTAT buttons simultaneously to toggle between Fahrenheit (F) and Celsius (C).



## Low Battery Indicator

### Transmitter Batteries

The transmitter has a battery-level indicator. When it indicates low battery voltage (see **Figure 13** below), install three new AAA alkaline batteries into the transmitter (see **“Transmitter Battery Installation”** on page 38).

Low Battery Indicator

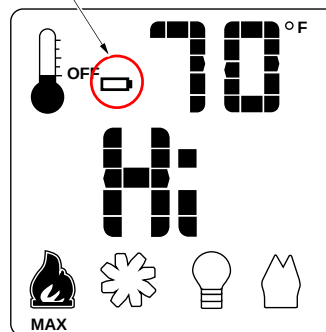

### IFC Batteries

The IFC (Integrated Fireplace Control) will “beep” twice when a transmitter button is pressed when the batteries are low. Install four new AA alkaline batteries into the battery box when this occurs (see **“Battery Installation”** on page 38). In applications where the appliance is required to provide heat, we recommend replacing the batteries before each heating season.

## Battery Replacement

### Battery Installation

Install four AA batteries into the battery holder (see **Figure 14** below). These batteries act as a power backup in case the household (AC) current goes out.

### Transmitter Battery Installation

Install the three included AAA batteries into the remote.

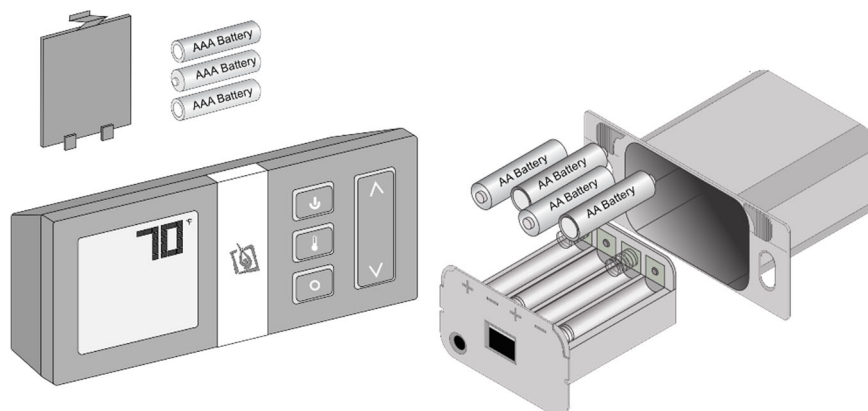

## Power Outages

The remote will work if the household current (AC power) is disconnected. The batteries inside the battery box will continue to power the heater but the accent light(s) and blower will not operate.

## Child-Proof Feature

The child-proof feature disables the control buttons, preventing un-wanted use of the remote.

- Press both the MODE and UP buttons simultaneously to turn this feature on and off.

**HINT:** This feature is especially useful while using the thermostat setting.

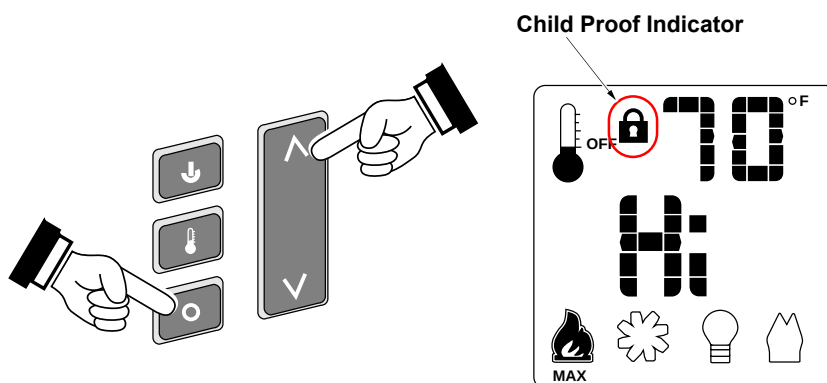
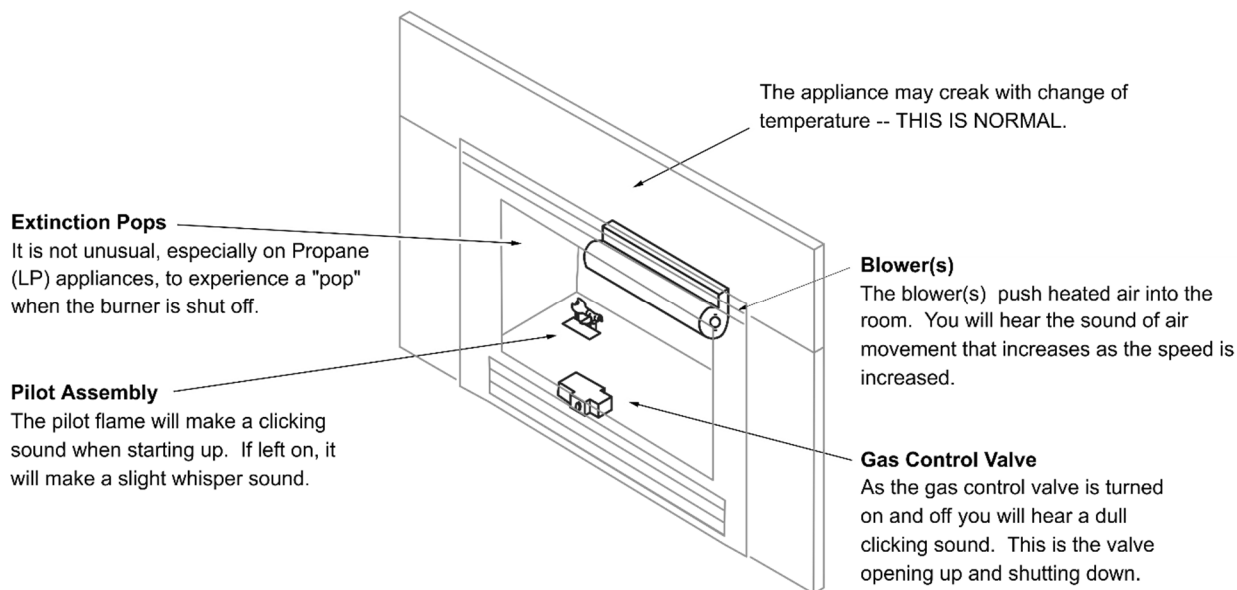

## Normal Operating Odors

This appliance has several areas that reach high temperatures. Dust or other particles in these areas may burn and create an odor. This is normal during start-up. You may notice the smell is more acute if the appliance was left idle for a long period.

**DANGER HIGH VOLTAGE:** Disconnect power before attempting maintenance or repair.

## Maintaining Your Heater's Appearance

Fingerprints or other marks left on the optional plated surface may become etched in place if they are not wiped clean prior to turning the heater on. Clean the plated surfaces with denatured alcohol and a soft cloth (with the heater cool). Other cleaners may leave a film that may become etched into the surface.

## Accent Light Replacement

The accent lights in your heater provide additional lighting. The bulbs will burn out over time. To replace, follow the directions below:

1. Shut off gas to the heater and let it cool for 15 minutes.
2. Remove the glass (see page 22) and media.
3. Replace the halogen bulbs with the following bulbs:

**NOTE:** Take care to not touch the bulbs with your fingers – use foam packing or a paper towel to handle the bulbs:

### Upper Accent Lights

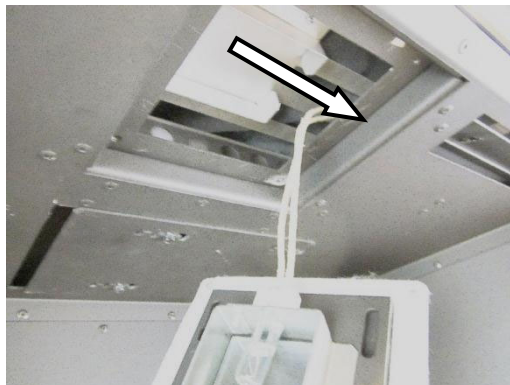
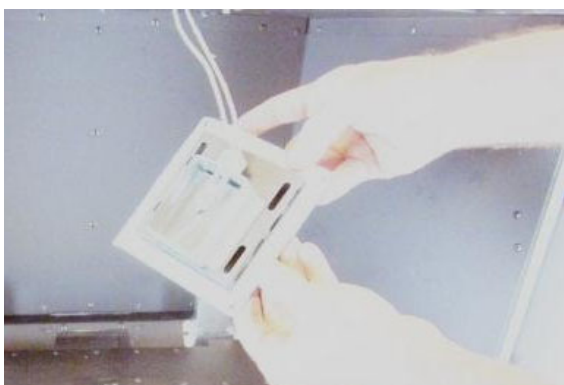
The upper accent light can be accessed by removing the 4 screws with a 1/4" nut driver, as shown below.



The upper accent light assembly drops down to expose the accent light.



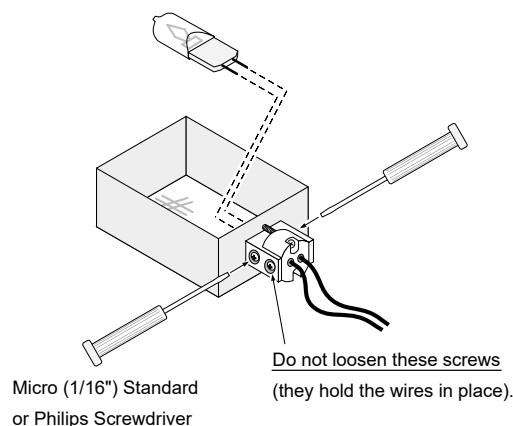
When replacing the assembly, carefully insert the wiring into this cavity to ensure the wiring is not pinched.



The upper accent light may now be accessed.



Loosen the two screws nearest the bulb to disengage the bulb from the holder. Remove the bulb from the holder. Replace the bulb, making sure not to touch the bulb with your fingers (grasp the bulb with the bulb packaging or a paper towel). Tighten the screws until the bulb is secure (do not over-tighten; this may damage the electrical contacts on the bulb).



## ***Under Light Bulb Replacement***

The Under lights in your insert provide additional lighting. The bulbs will burn out over time. Replace the halogen bulbs with the following bulbs:

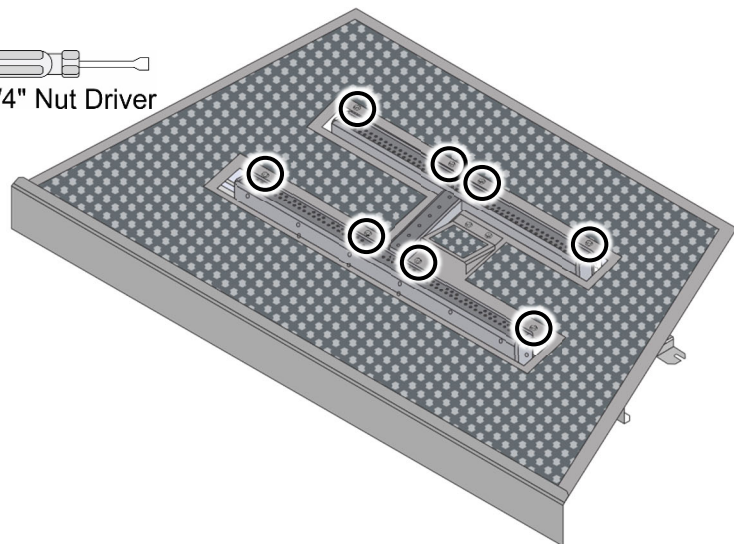

To replace, follow the directions below:

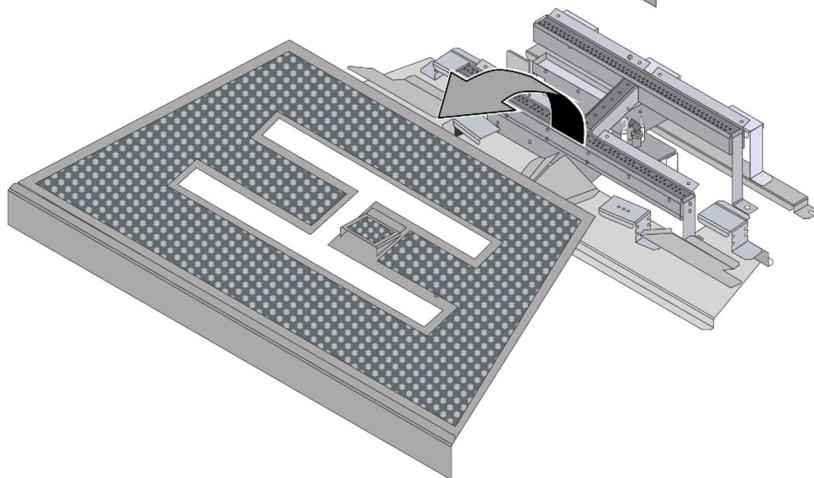
1. Shut off gas to the Insert and let it cool for 15 minutes.
2. Remove the glass assembly (see page 23).
3. Remove glass media from the media tray.



4. Use a 1/4" nut driver to remove the (8) media tray attachment screws that secure the tray to the burners (set the screws aside for reinstallation).



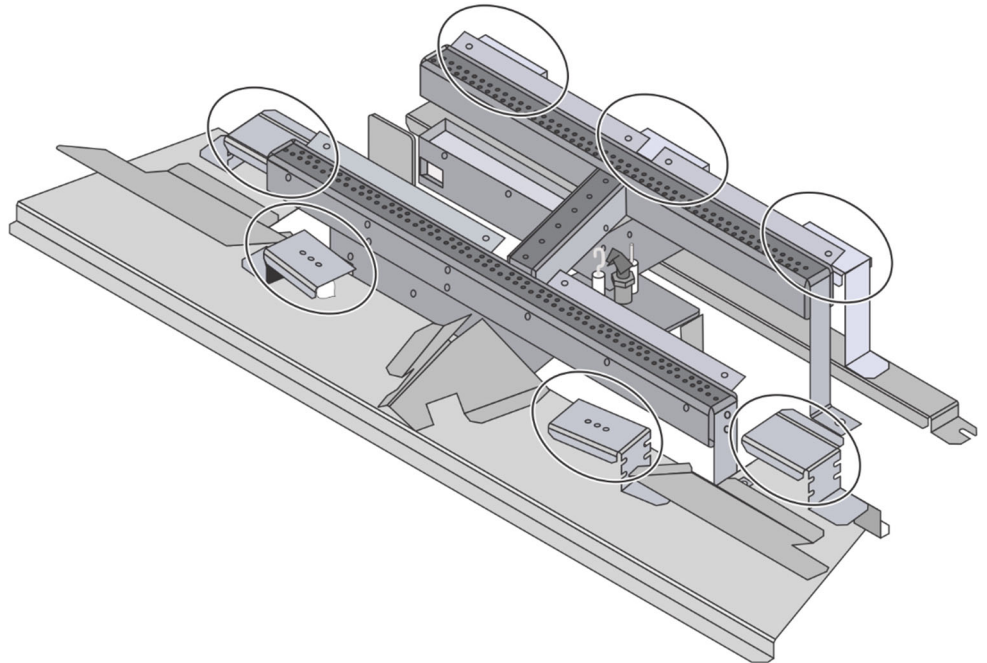
5. Lift the media tray up and out of the firebox.



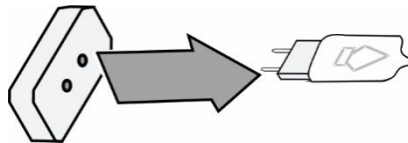


There are (7) bulb sockets in this appliance (see illustration).

**NOTE:** It may be easier to access the (3) rear sockets by removing the burners (see “Burner Removal” section for details).

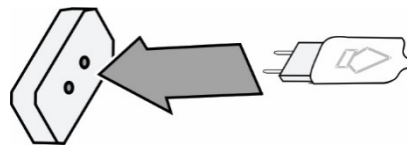


6. Remove the bulbs from the socket by pulling the bulbs directly away from the socket (do not twist).



7. Gently insert the pins on the replacement bulb into the holes on the socket.

**NOTE:** Take care to not touch the replacement bulbs with your fingers – use foam packing or paper towel to hold the bulb

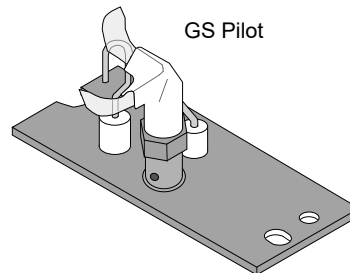


8. Return the fireplace to its correct configuration.

## Yearly Service Procedure

**WARNING:** Failure to inspect and maintain the stove may lead to improper combustion and a potentially dangerous situation. We recommend the following procedures be done by a qualified technician.

- Shut off gas to the fireplace and let it cool for 15 minutes. Remove the glass. Inspect and operate the pressure relief mechanism to verify relief mechanisms are free from obstruction to operate.
- Clean glass window with a suitable fireplace glass cleaner. Abrasive cleaners must not be used. Be careful not to scratch the glass when cleaning.
- Vacuum and clean any debris in the firebox.
- Check all accessible gas-carrying tubes, connections, pipes, and other components for leaks.
- Inspect the burner and firebox. Make sure the burner is not warped, cracked, or damaged. Check the firebox and area around the pilot to make sure there is no damage. Inspect primary air openings for blockage. If any problem is found, discontinue use and contact your dealer for service.
- Inspect the area behind the access door; clean if necessary. Check the gas control valve and the gas lines. If damage is found, discontinue use and contact your dealer for service. Clean the air channels, ducts, and blower (if applicable)
- Inspect vent and vent termination for sooting, obstructions, or damage. Make repairs as needed. Remove any debris or vegetation near the vent termination. Contact your dealer if any sooting or deterioration is found near the vent termination.
- Reinstall the glass assembly. If the glass is damaged, replace it. Make sure the gasket along the perimeter of the glass contacts the face of the firebox and forms an air-tight seal. If it does not, re-align or replace the gasket to ensure an air-tight seal.
- Turn the pilot flame on (continuous pilot). It should touch approximately 3/8" of the top of the flame sensor (see below). If it does not, contact your dealer.

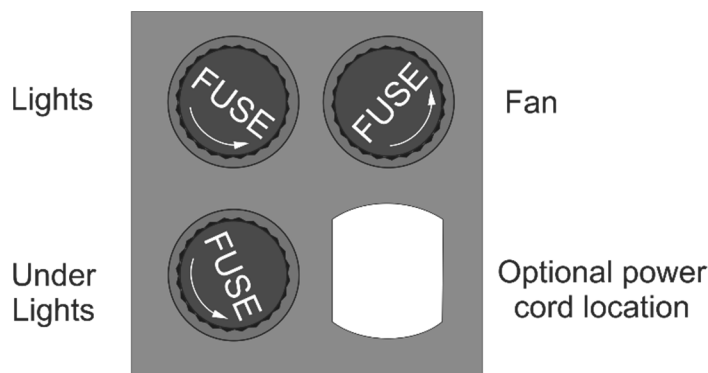


- Start the main burner. Inspect and ensure the lighting of the main burner occurs within 4 seconds of the main gas valve opening.
- Test the flame failure response time of the flame safety system. It must de-energize the safety shutoff in no more than 30 seconds.
- After 15 minutes the flames should be orange/yellow and not touch the top of the firebox. If the pilot or main burners do not burn correctly, contact your dealer for service. Monitor blower operation

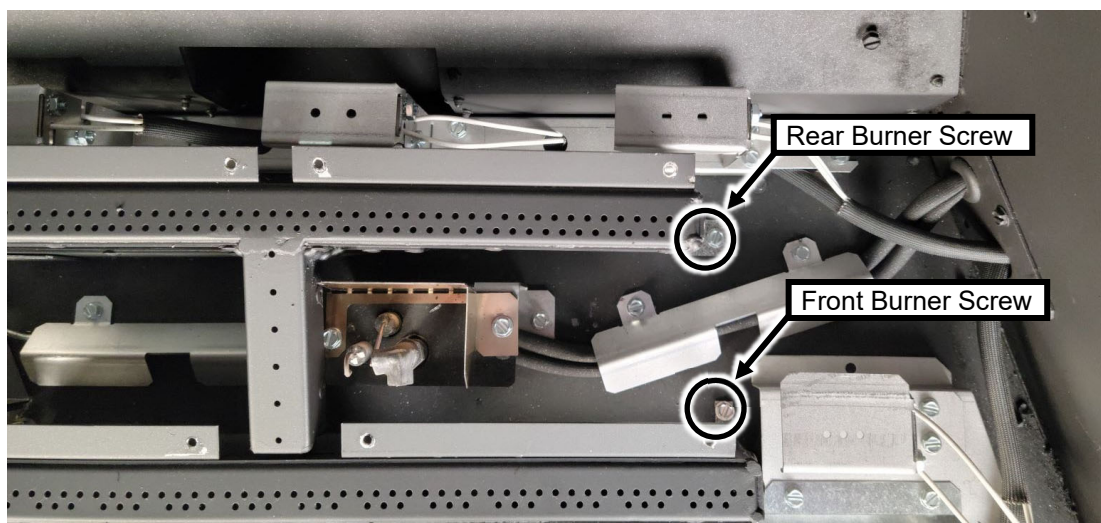
**Convert the appliance prior to installing the gas line to ensure proper gas use.**

The GSR Stepper Motor Kit (4-pack = 94400999), (single = 250-01463) is required for converting this appliance to LP. The kit contains the stepper motor (regulator) and Torx wrench.

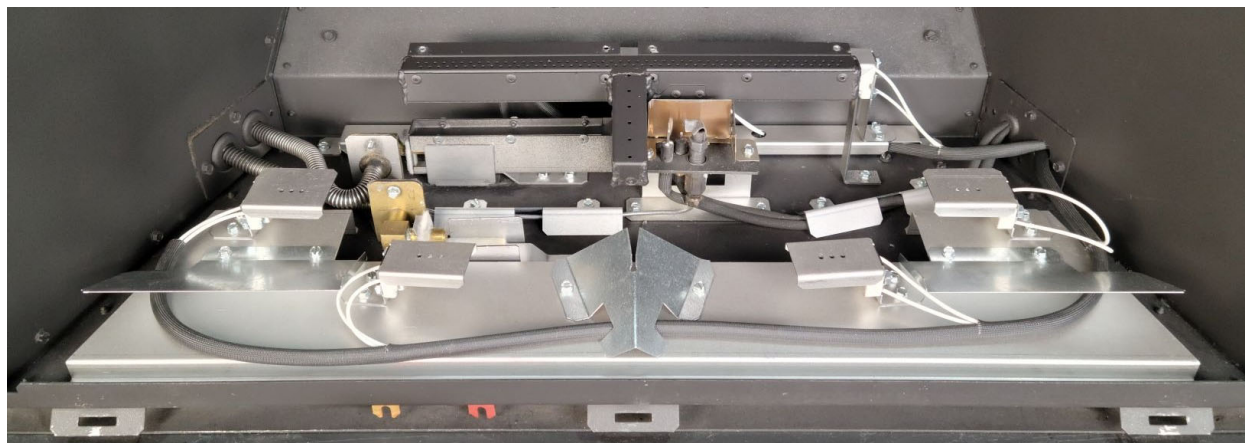
1. Access the firebox.
2. Remove the (8) screws that secure the media tray to the burners (set the screws aside for re-installation). Lift the media tray and remove it from the firebox.



3. Remove the (2) screws that secure the burners to the floor of the firebox (set screws aside for re-installation).



4. Lift the front burner and remove it from the firebox.

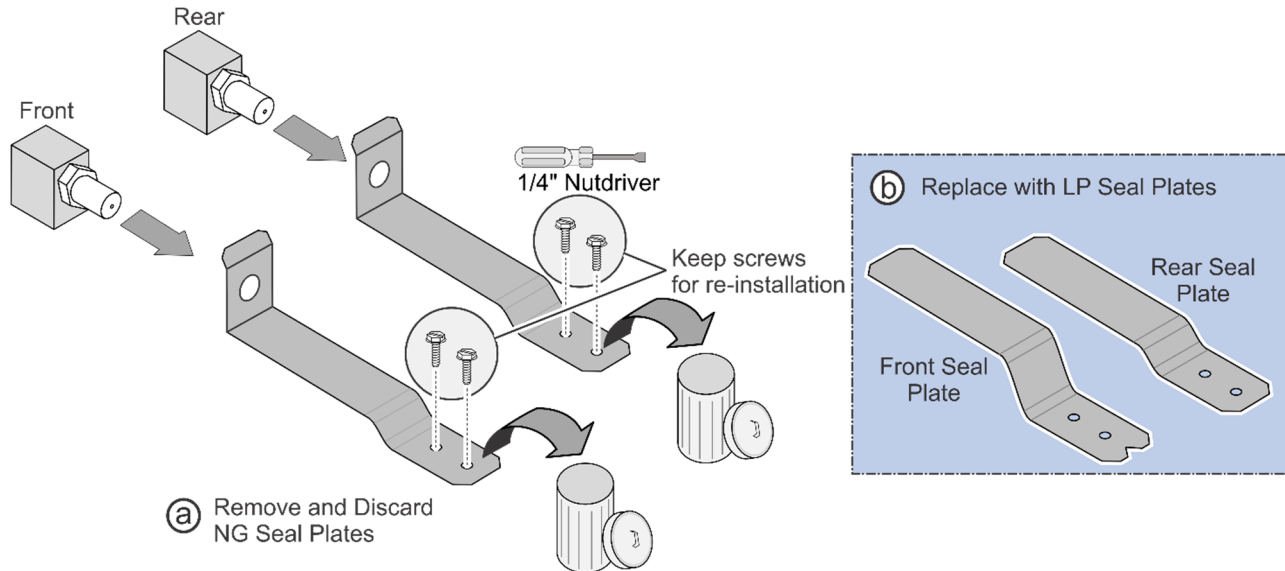


5. Lift the rear burner and remove it from the firebox.





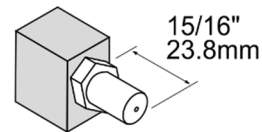
6. Remove and discard the stock seal plates. Install the LP seal plates as shown below.



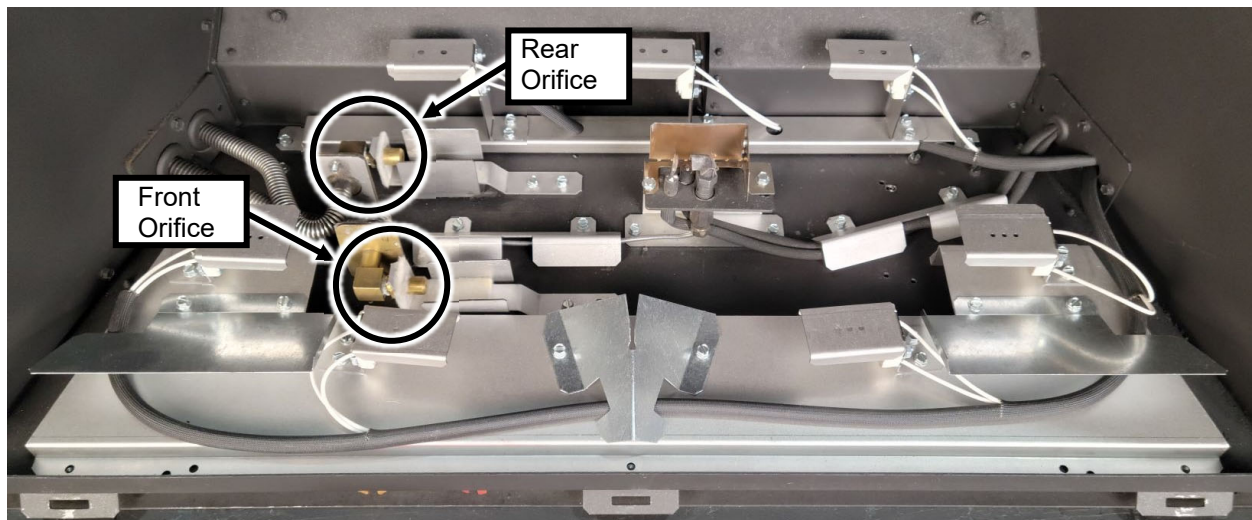
7. Install the LP (propane) orifices.

Apply thread sealant to the LP orifices prior to installation. Use the chart below to identify the correct orifices.

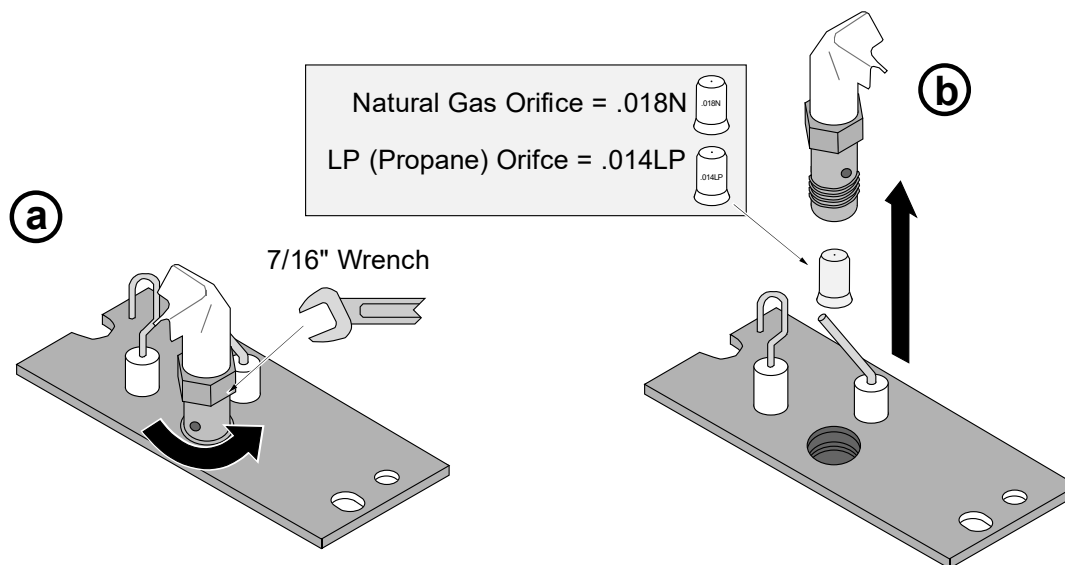
Screw each LP orifice until orifice protrudes 15/16" (23.8mm) indicating full insertion (use wrench to support manifold when re-attaching orifice).



| ORIFICE SIZE (ID)    | Natural Gas | LP (Propane) |

| Front Burner Orifice | #50 DMS     | #60 DMS      |
| Rear Burner Orifice  | #48 DMS     | 1.2mm DMS    |



8. Install the LP pilot orifice following the directions below.
  - (a) Use a 7/16" open-end wrench to remove the pilot hood.
  - (b) Remove and discard the Natural Gas (NG) orifice. Place the LP orifice in the pilot assembly then replace the pilot hood, tightening the pilot hood until it is snug (do not over-tighten).



9. Replace the firebox components. Restore the fireplace to the correct configuration. Install the firebacks before re-installing the burner.
10. Access the stepper motor (shown below). The stepper motor (adjustable regulator) has an installation sheet included with it – make sure to follow all of the directions. Disconnect the wiring from the stepper motor. Remove the stock stepper motor and replace it with the LP version. – **MAKE SURE IT IS CORRECTLY ORIENTED.** Secure using the screws included with the motor – tighten to 25 Lb.-inches. Leak test this area after installation to verify proper installation. Re-attach the wiring.



11. Restore the appliance to the correct configuration. Make the gas line connection, bleed the gas line (if applicable), start the heater, and thoroughly leak-test all gas connections and the gas control valve.

### GLASS FIREBACK WARNINGS

**HANDLING THE FIREBACKS:** The glass firebacks are fragile – especially the edges. Take care to prevent contacting/scraping the glass against metal or rough surfaces. You may wish to lay out a blanket during installation in case you need to set the firebacks down.

We recommend the use of gloves and safety glasses during the installation of the glass firebacks.

### CLEANING

These firebacks require periodic cleaning. Do not use ammonia-based cleaners (this may cloud the glass). We recommend ammonia-free glass cleaner (i.e. vinegar and water) to clean the fireback.

### CURING BLACK-PAINTED FIREBACKS

The black painted firebacks will fully cure under heat. Run the appliance on low for several hours to cure the paint. The firebacks may be touched-up using Forrest “Metallic Black” paint.

## Installation



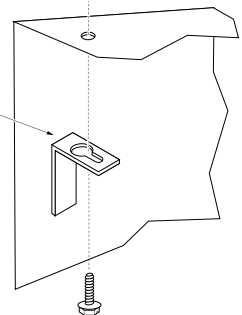
The firebacks are installed with the media tray removed.

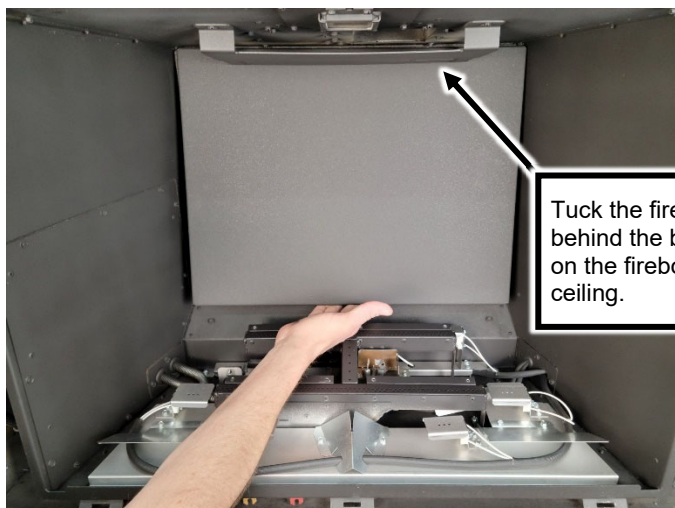
1. Remove the media tray (see Owner's Manual).
2. Remove the two side fireback clips from the firebox ceiling. They are located at the outward edges of the firebox near the glass opening.



The side fireback clip has a keyhole slot. It can be removed by loosening the screw and sliding the clip out.



3. Place the rear fireback inside the firebox as shown below.



Tuck the fireback behind the baffle on the firebox ceiling.





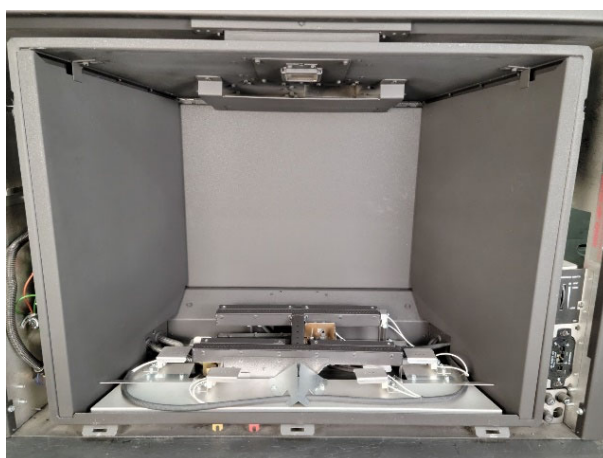
4. With the rear fireback resting in place, install the left fireback into the firebox as shown below.



5. Replace the left fireback clip to secure the right fireback in place



6. Install the right fireback and secure using the fireback clip. The firebox should now look like the photo below.

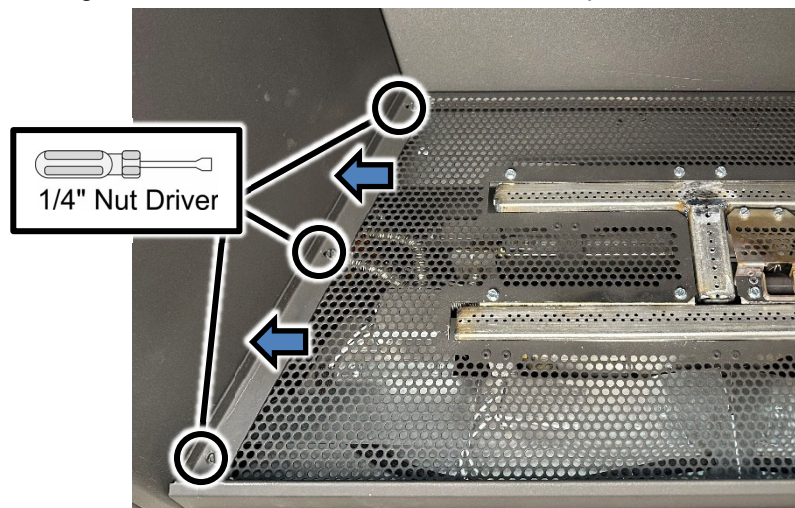


7. 7. Replace the media tray. Screw the media tray down to the burner.

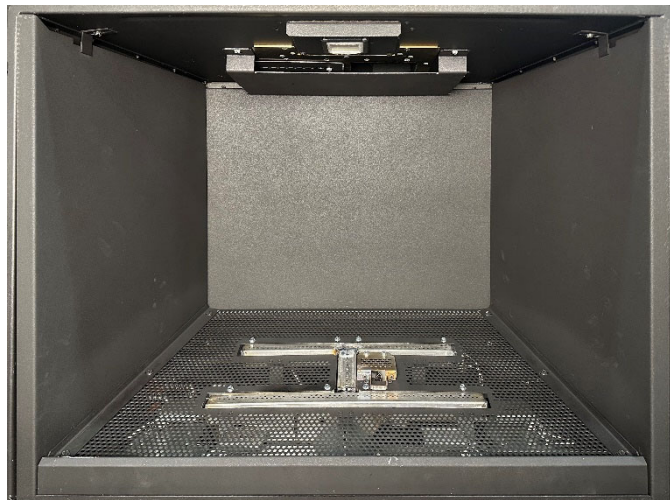
**NOTE:** The tray may not fit unless the firebacks are all the way against the fireback walls.



8. After the media tray is installed, use a 1/4" nut driver to loosen the screws (3 per side) on the side media tray filler brackets. Slide the brackets toward the side firebacks until they are touching the panels and retighten the screws to secure the brackets in place.



9. When the fireback installation is complete, it should look like the picture below.

At a minimum, every installation requires a base layer of spreadable media (Crushed Glass or Embers and Ember-Glo (EG) Glass kit) to cover the media tray and burners. The following base layer materials are available:

## Crushed Glass Installation (Optional)

### Measuring Glass Quantity

Travis Industries offers glass in 10-lb. boxes. The 430 Mod-Fyre uses **6 lbs.** of glass so it is important to measure out the appropriate amount of glass for installation. Use a liquid measuring cup to accurately determine the amount of glass used.

**1 Level Cup (8 fl. oz.) (240ml) = 0.95 lbs.**

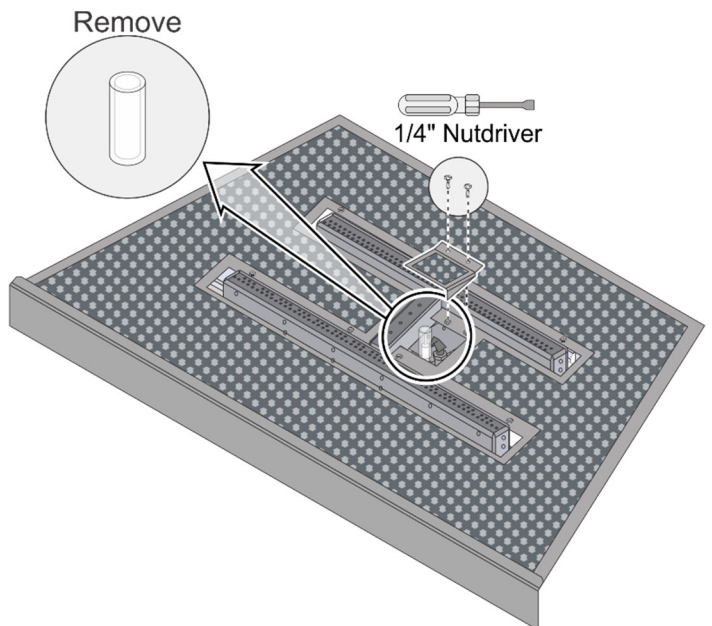
**So...1 Slightly Rounded Cup = 1 lb.**



## ! WARNINGS !

- **Do not allow the crushed glass to block the air slots or to become too thick (maximum 1 layer deep on the burner). Failure to properly install glass may lead to sooting and improper burning.**
- **Make sure the gas control valve is OFF and the heater is cool prior to conducting service.**
- **If using propane (LP), convert the appliance before installing the media**
- **This appliance requires the use of a fireback kit. Install the Fireback BEFORE installing the media.**

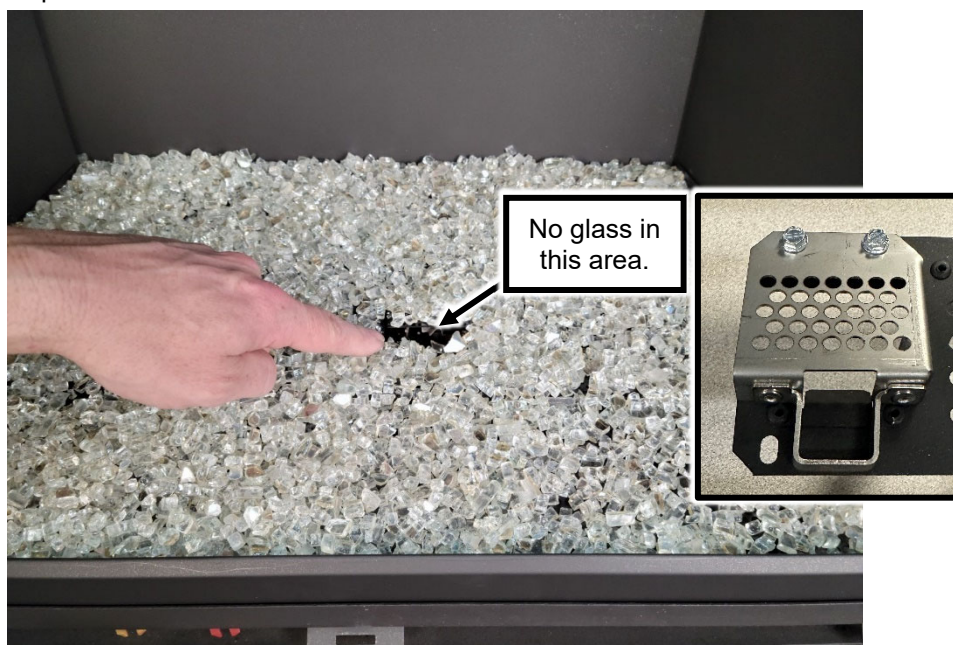
1. Use a 1/4" nut driver to remove (2) screws that secure the pilot cover to the media tray and remove the pilot cover. Gently pull the silicone sleeve from the spark electrode on the pilot assembly and re-install the pilot cover (make sure not to overtighten the screws).



2. Spread an even layer of crushed glass over the media tray and burner. The glass must be only (1) layer thick on the burners but can be (2) layers thick on the media tray.



3. Make sure glass does not drop down into the pilot area below the cover and that the opening indicated below remains open.



4. The firebox should look like the picture below when the glass installation is complete.





**Embers and EG Glass (Optional)****! WARNINGS !**

- Do not allow the glass or rock material to block the air slots or to become too thick (maximum 1 layer deep on the burner). Failure to properly install the Rock Ember material may lead to sooting and poor performance.
- Make sure the gas control valve is OFF and the heater is cool prior to conducting service.
- If using propane (LP), convert the appliance before installing the media
- This appliance requires the use of a fireback kit. Install the Fireback **BEFORE** installing the media.

**Overview**

This kit comes with ember glass (4lbs) and (2) sizes of ember material (1/2 lb. of small rocks and 4 lbs of large rocks). Because this kit includes more media than needed, we recommend keeping the extra glass and rock media for future use.

**Amount of Media Needed:**

- Ember-Glo Glass - 3 lbs. (approximately 3 cups).
- Small Rock - 1/3 lbs. (approximately 1 cup).
- Large Rock - 3 lbs. (approximately 8 cups).

**Installation Notes**

- Discard rock at the bottom of the bag that has disintegrated (turned to small, sand-like material).
- Put down the EG glass first. Cover the entire media tray with EG Glass (Do not cover the burner).
- Put down the large rock next. Cover the EG glass with large rock.
- **NOTE: Do not place large rocks over any burner ports** (This will cause sooting).
- Place one layer of small Ember Rock over the burners.
- Do not stack media in piles that may fall over or block airflow.

- Install a base layer of either Crushed Glass or Ember Rock before placing any of this media kit.
